Brief Description of Proposal -
Dane County Parks has secured a Wisconsin Department of Natural Resources – Wild Turkey Stamp Funding grant for \$30,000 for restoration projects.

Current Policy or Practice -
Acceptance of grant funds requires County Board approval.

Impact of Adopting Proposal -
The goal of the habitat projects are to increase habitat quality for wild turkey and other species that require grassland and oak savanna. The Department Director and the Botanist/Naturalist are authorized to execute documents, including grant agreements and amendments, necessary to accept the grant funds.
