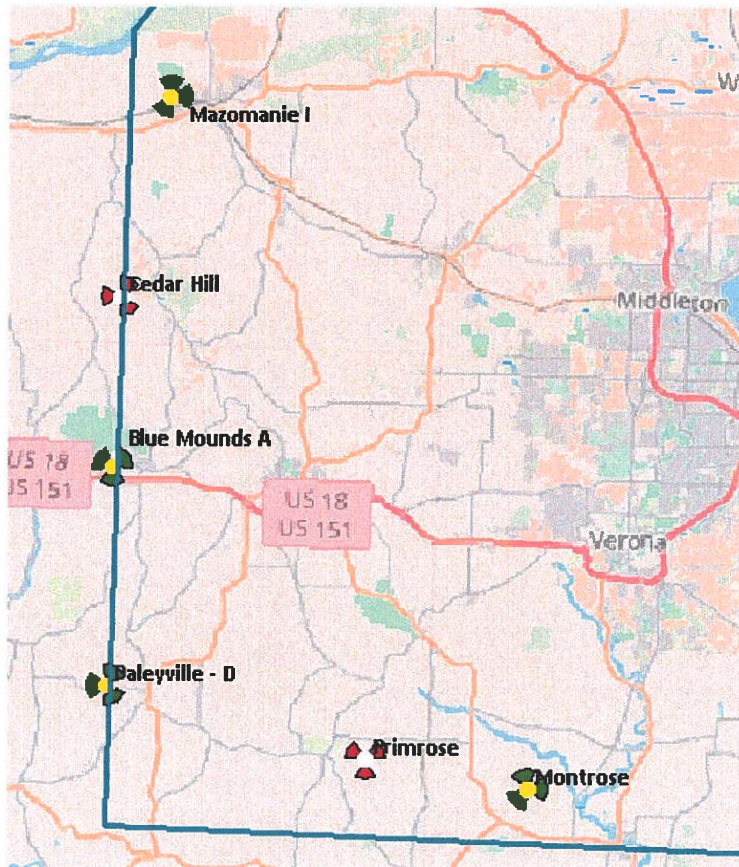


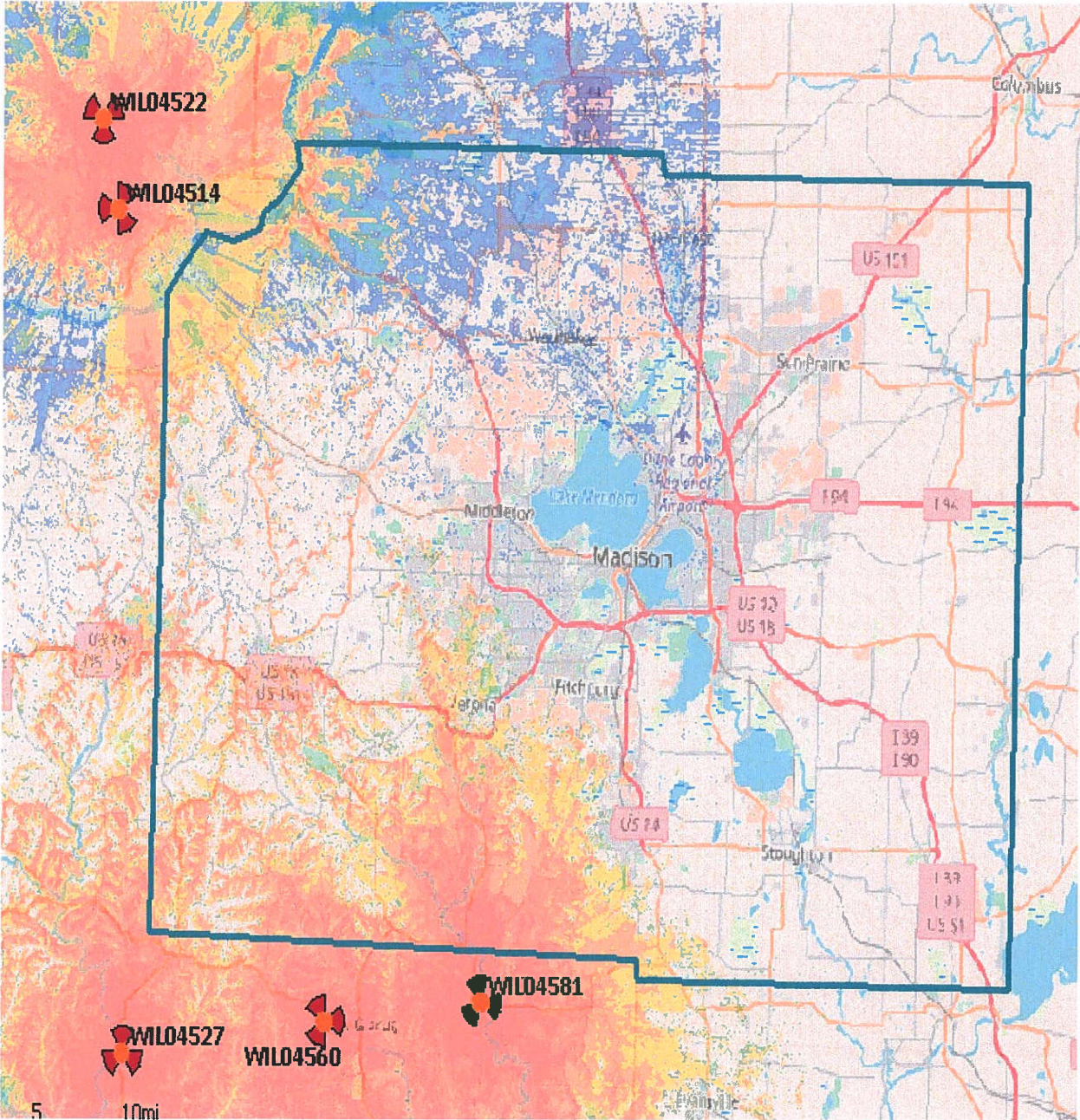
Here is a visual of our future sites



The sites Montrose, Primrose, and Mazomanie are all sites that we are trying to lease, zone, and build in Dane County. They are sites that we are trying to build to increase our coverage foot print. The other sites Cedar Hill, Blue Mounds, and Daleyville are sites we have leased and zoned and are under construction outside of Dane County but within one mile of the Dane County border. All the towers in the above map are for coverage.

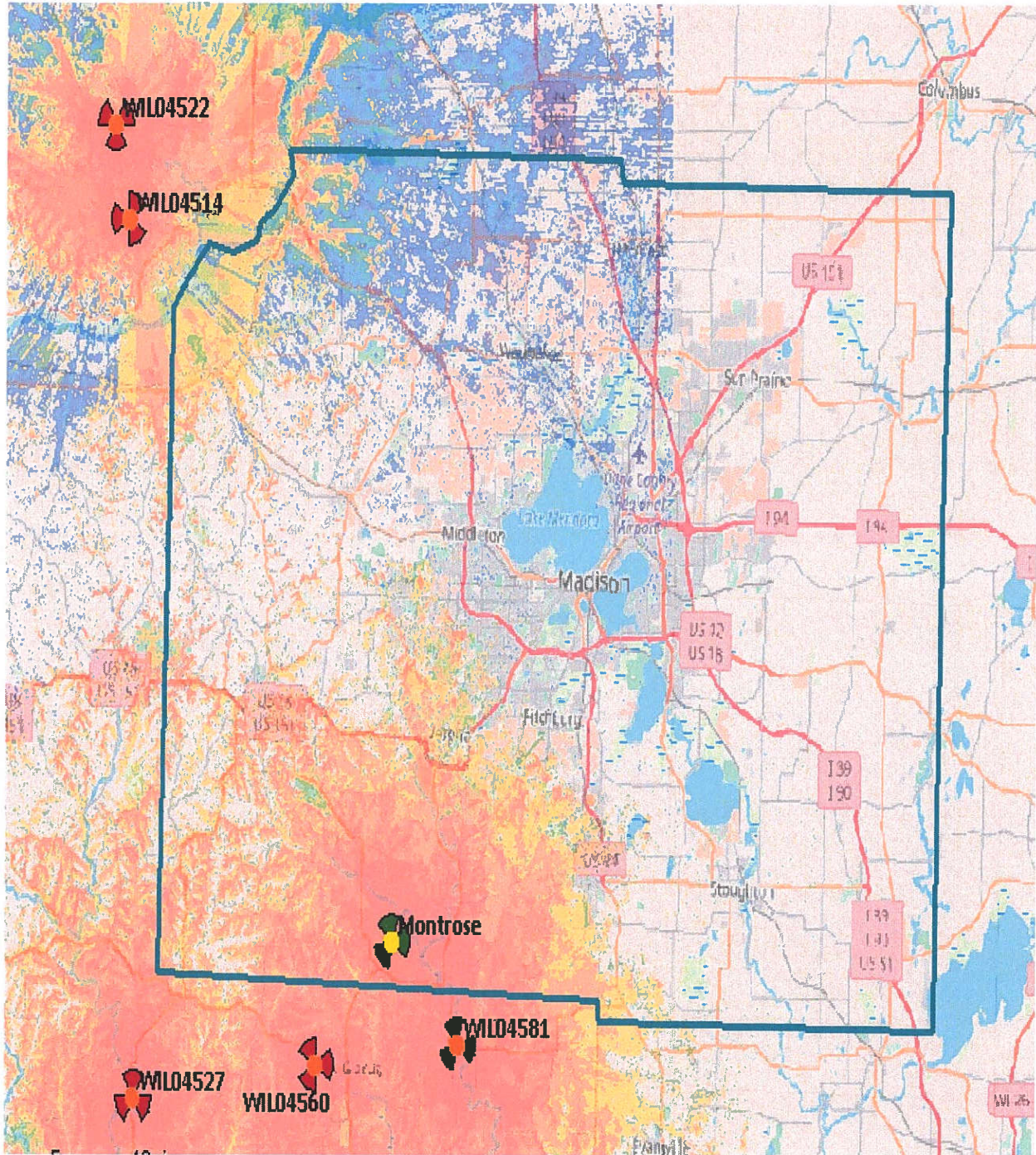
Existing Coverage (sites in our network Surrounding Dane County)

This is our existing coverage in Dane County. Other than the coverage that spills into Dane County from the neighboring counties we have no coverage in Dane County.



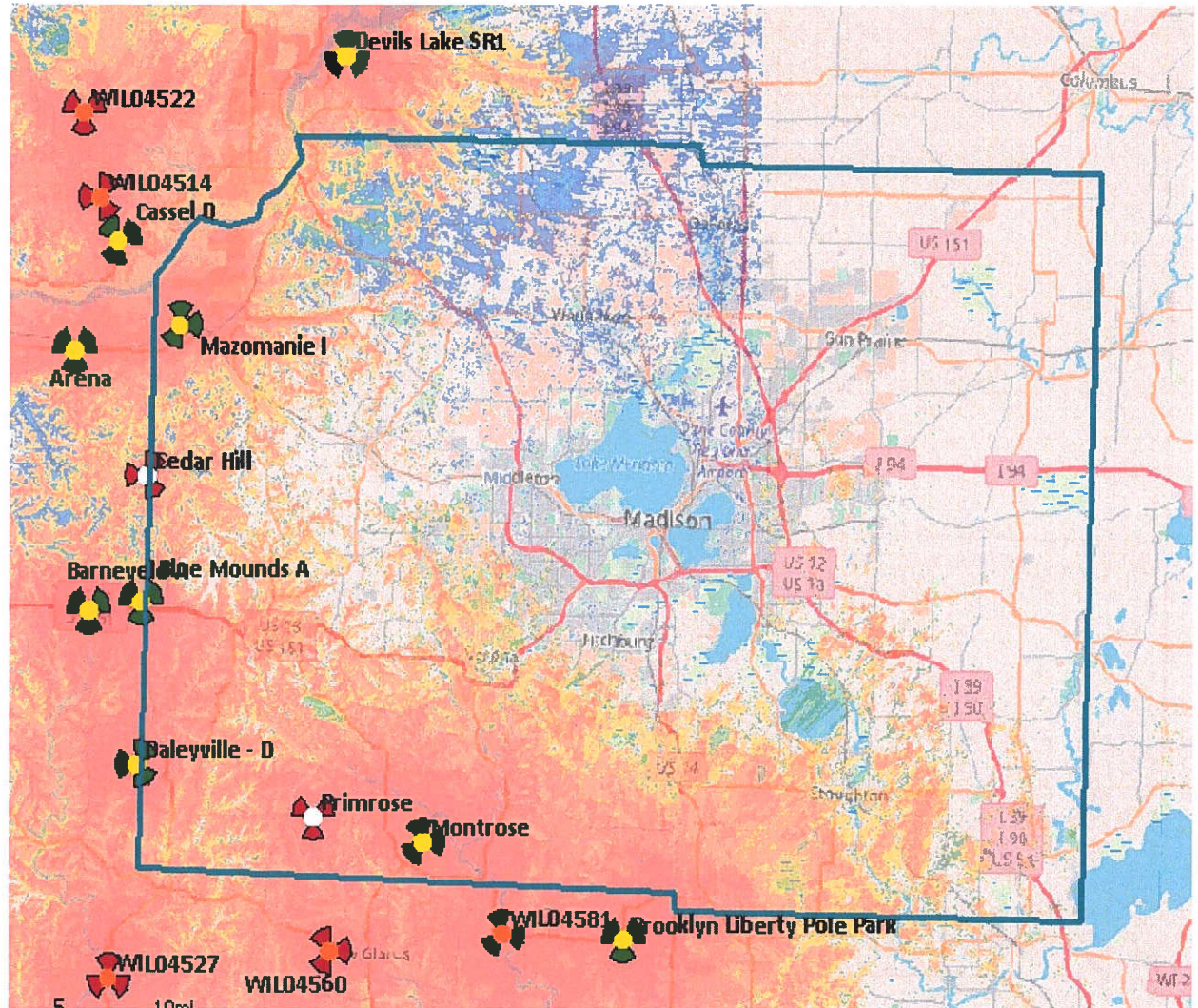
Existing Coverage with Montrose

This map shows our existing coverage with the site Montrose turned on. This increases our coverage in Dane County. In the previous map we only had coverage from the surrounding counties but Montrose introduces our coverage in Dane County in the area where the search ring was created to cover.



Future Coverage with Montrose

Finally, this map shows our final coverage in Dane County. Coverage provided from the surrounding Counties except for Mazomanie, Montrose, and Primrose. Mazomanie provides this coverage in the North West corner of the County. We have been working on the search area of Mazomanie for well over a year. We have worked with the County on their towers but found they were not an option for us. Montrose provides coverage in the South West part of Dane County. This has been leased for a while, but we could not enter zoning. Primrose provides coverage in the South West part of Dane County. We are working on the search location for this site.

6. Bug Tussel Wireless, LLC has performed a thorough search of this area and found that the proposed location best suits our needs for Line of Site to cover the most customers.





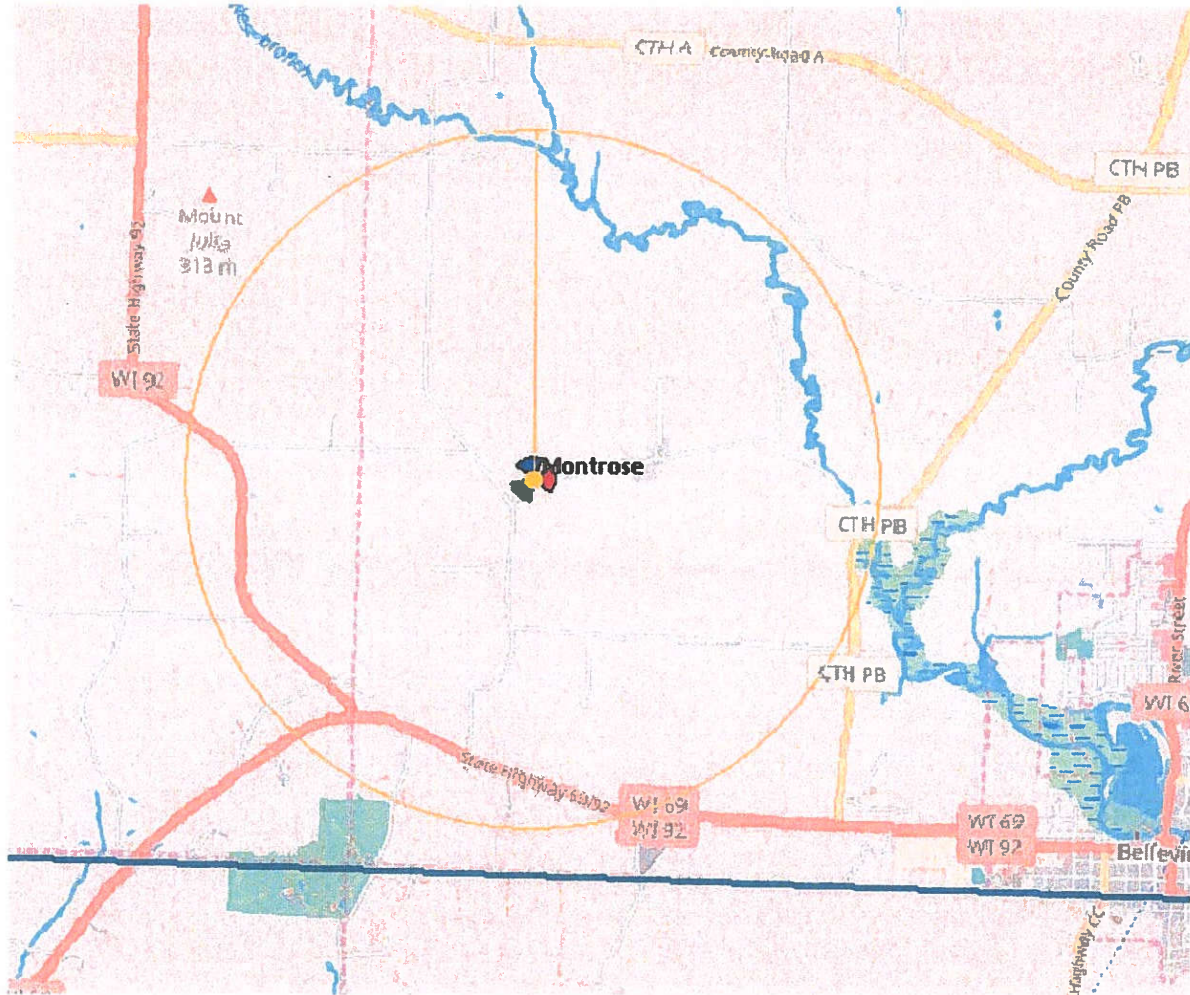

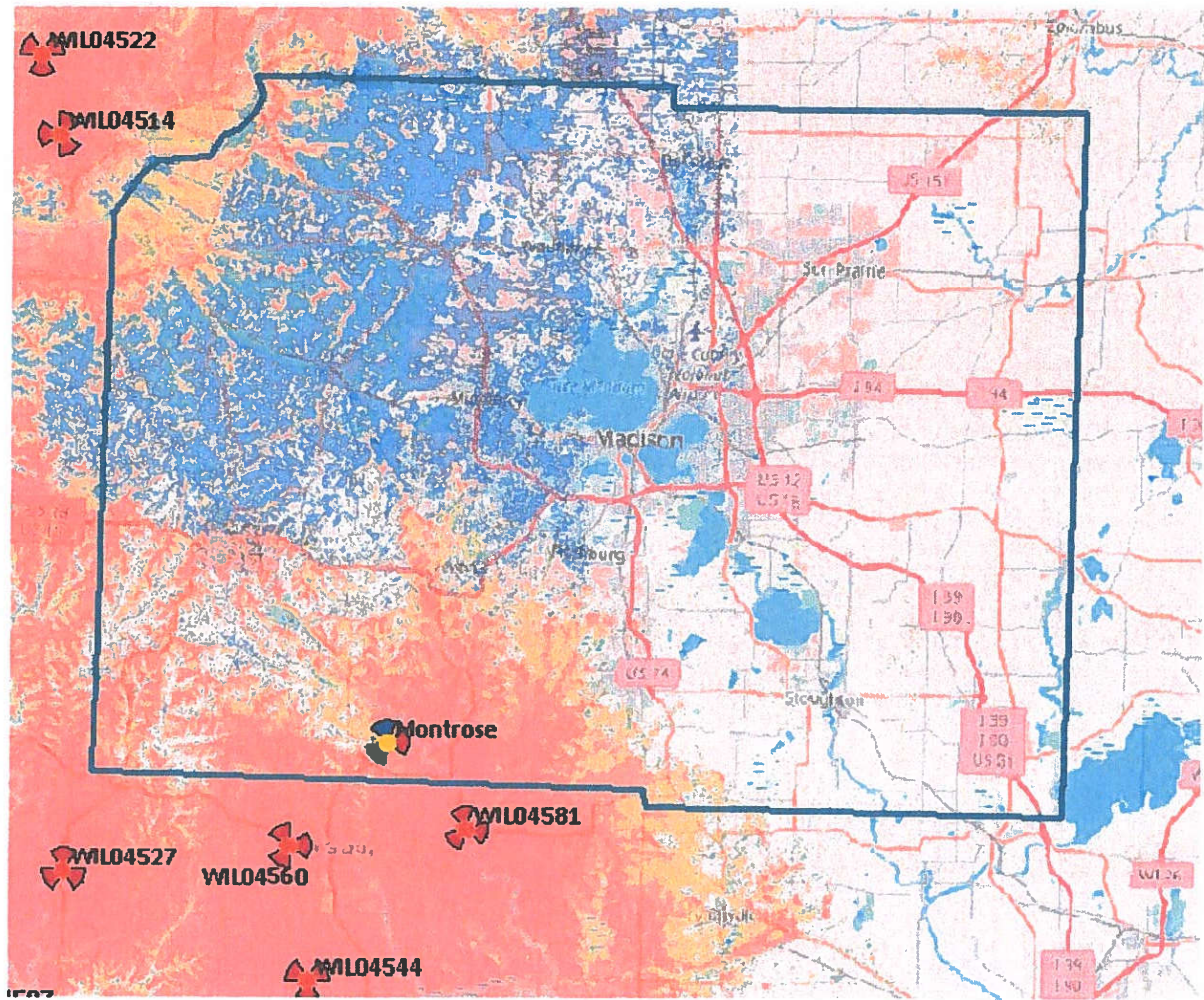
Search Ring Location: 42.881250 -89.587639

Proposed Tower Location: 42.881250 -89.587639

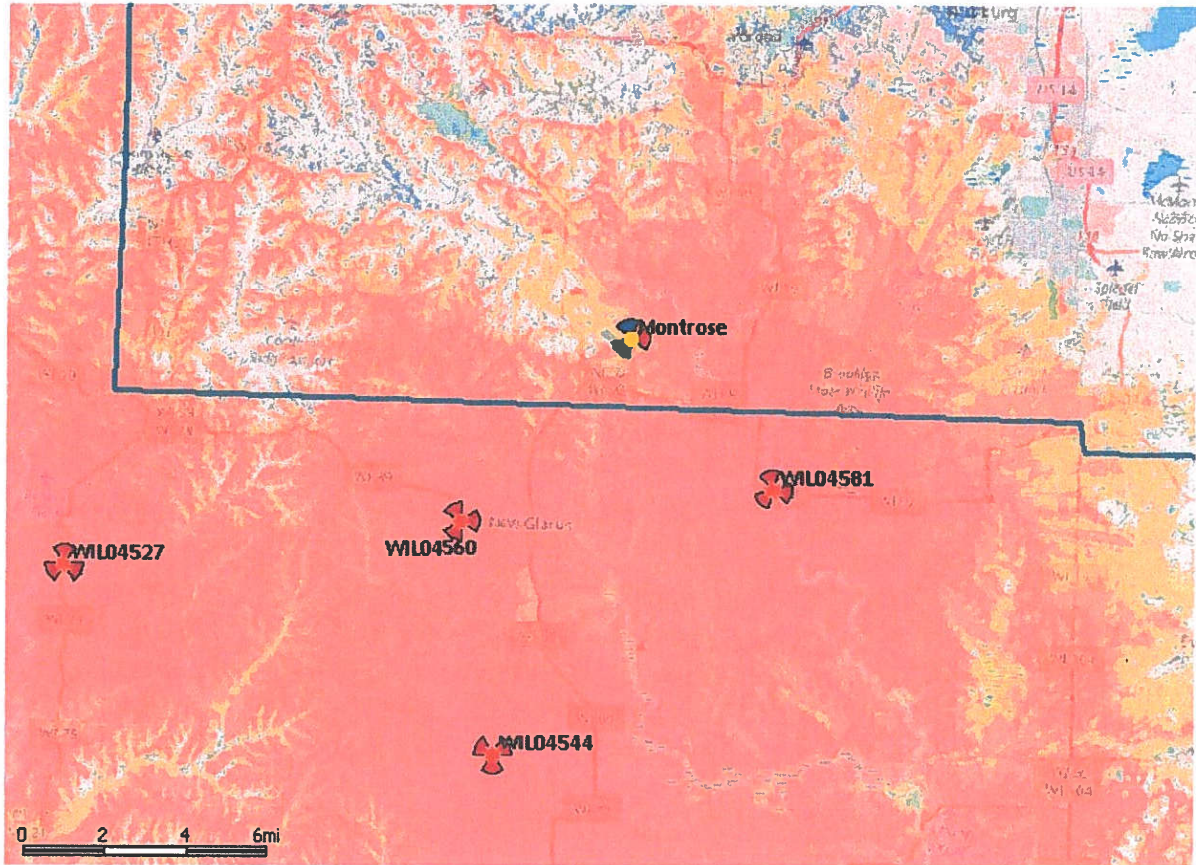
Design Search Ring



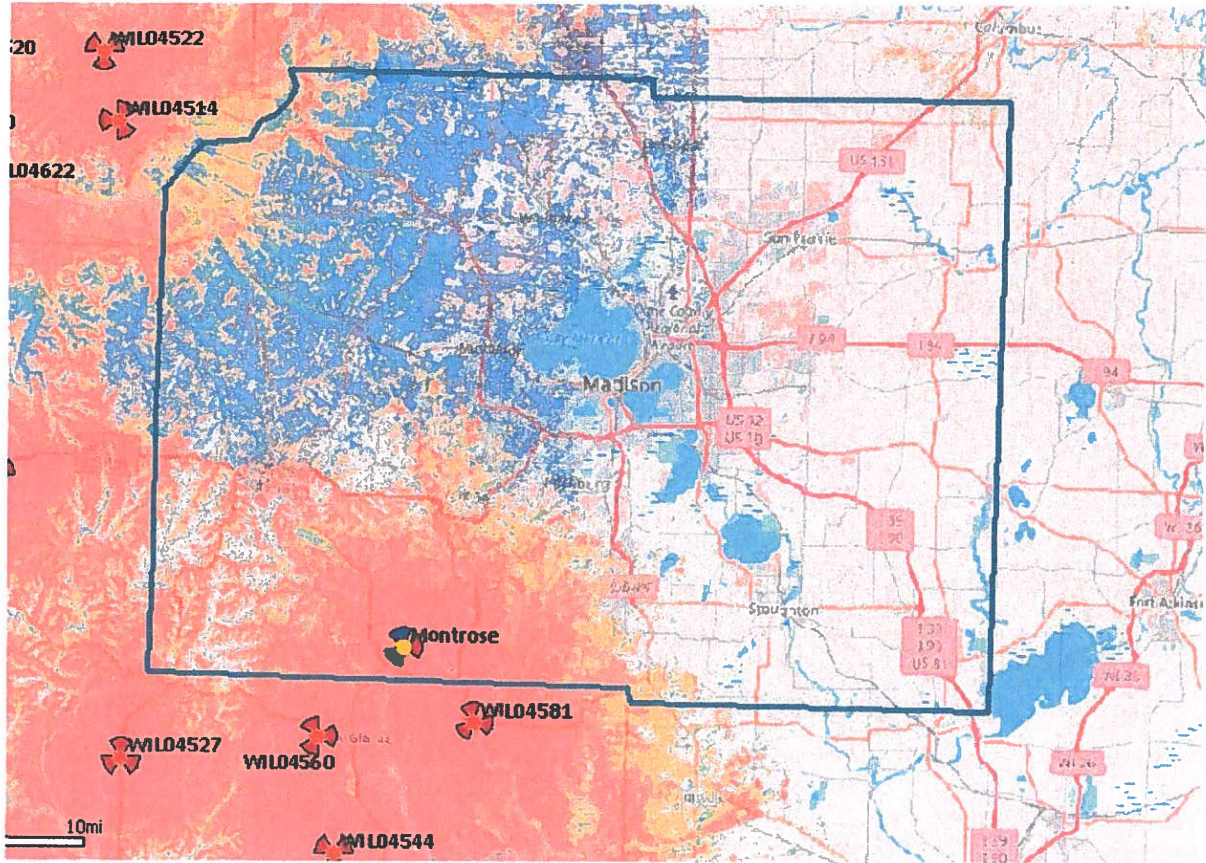
County Existing Coverage with Montrose (Off)



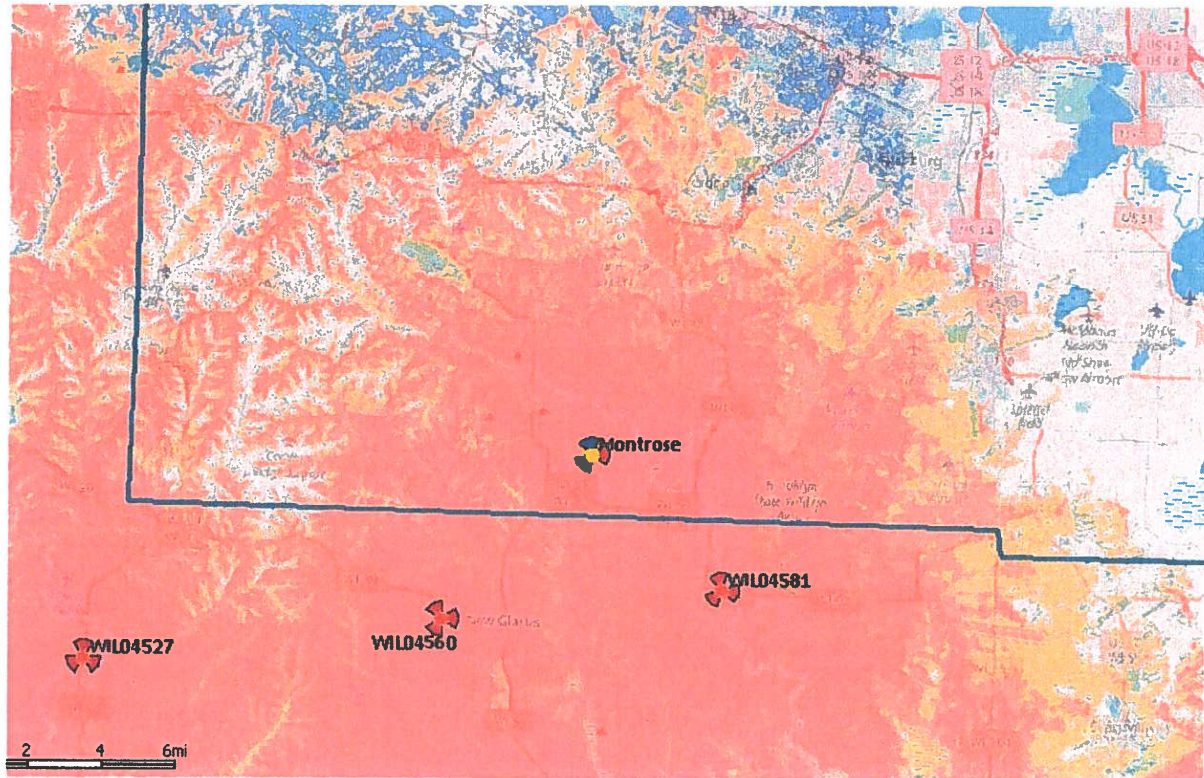
Same as above zoomed in view
