AUTHORIZING AN INCREASE IN THE EXPENDITURE LIMIT FOR THE SHERIFF'S OFFICE PETTY CASH REVOLVING FUND

Brief Description of Proposal -

The Dane County Sheriff's Office maintains a petty cash fund of \$4,200. The single transaction maximum expenditure allowed fr om this account is currently \$100. Request an increase in the single transaction expenditure limit from \$100 to \$300.

Current Policy or Practice -

Funding advances from petty cash routinely go over \$100 due to increased costs, a typical transaction advance is between \$200 and \$300.

Impact of Adopting Proposal -

The maximum single transaction threshold of \$100, from the Sheriff's Office petty cash revolving fund, has not increased since 2008 and is insufficient to meet Departmental needs. The fund is used to advance money to Deputies who make out-of-state prisoner conveyances, conduct investigations, attend out-of-state conferences, and to make miscellaneous and emergency purchases including registration and title transfer of new vehicles, and CDL permits and licenses.
