# **Policy Analysis Statement:**

#### Brief Description of Proposal -

The Department of Transportation, Bureau of Transportation Safety, State of Wisconsin, is providing funding for an Alcohol E nforcement Initiative to reduce the number of alcohol related crashes by persons leaving area festivals and community events. The grant provides f unding for a Safe Rider Program and a media plan.

## Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board.

## Impact of Adopting Proposal -

Changes in driver behavior can be effective in reducing motor-vehicle crashes and injuries. Enforcement of traffic safety laws, reinforced by media and public education leads to safer driving behavior choices. Annual motor-vehicle crash-related fatalities had been decreased and factors contributing to this decline included increased public awareness of the dangers of drinking and driving, new and tougher state laws, stricter law enforcement, and prevention programs that offer alternatives to driving such as safe rider programs (e.g., taxicabs, public transportation, and designated drivers, including responsible alcohol-serving practices).
