Director Jones informed the Commission we have regained two of our destinations that were lost during the pandemic. Along with new weekly flights to Miami, we have also recovered both LaGuardia and Washington National.

2. Activity Report

Director Jones stated it's a slow climb to recover both the passengers and destinations we lost from the pandemic. For August 2021 passengers were up 29.2% over 2020. We are still at 60-65% from where we were in August of 2019. As we are a very business centric community and airport, it is important to regain the business travelers and destinations.
