AUTHORIZING A CONTRACT BETWEEN DANE COUNTY AND INMATE CALLING SOLUTIONS, LLC, FOR DANE COUNTY JAIL INMATE TELEPHONE SERVICE

## **Policy Analysis Statement:**

#### Brief Description of Proposal -

Request approval to award a contract to Inmate Calling Solutions, LLC, to provide telephone and video visitation service to inmates in the Dane County Jail. Dane County will receive no commission from Inmate Calling Solutions for providing phone and video visitation service to inmates however, Inmate Calling Solutions will be assessed an administrative fee of \$447,000 annually to cover the cost of administering inmate phone and video visitation service in the Dane County Jail system. The administration fee will increase 3% per year for the duration of the contract.

### Current Policy or Practice -

Contracts for amounts exceeding \$100,000 require County Board approval.

## Impact of Adopting Proposal -

For inmates, one of the few methods of maintaining contact with loved ones is communication through in-person visits, letter writing, and phone calls. Many prisoners are incarcerated hundreds of miles from loved ones, making in-person visits too expensive, phone calls are often the only way to connect families and maintain bonds. Phone service in the jail affords inmates a reasonable opportunity to maintain contact with family and
