# **Memorandum of Understanding**

Under Wisconsin Cannabis Enforcement and Suppression Effort (WI CEASE), the Wisconsin Department of Justice, Division of Criminal Investigation (DCI) will provide reimbursement to each participating county/task force/agency for overtime expenses associated with the eradication and suppression of illegal marijuana as outlined in the WI CEASE Standard Operating Procedures (SOP).

#### As a condition of receiving funds under WI CEASE, the undersigned herby agrees to:

- 1. Appoint a WI CEASE agency coordinator and alternate
- Submit a completed Marijuana Eradication Report (MER), for any and all marijuana seizures within their jurisdiction (whether overtime is being reimbursed or not) that meet the following requirements:
  - · Any number of plants
  - · One or more pounds of processed marijuana
  - · One or more ounces of THC wax/oil or THC edibles
- 3. Request reimbursement earned conducting marijuana operations or processing of qualifying seizures of evidence on the date seized using the actual overtime rate of the officer/agent (fringe benefits are not included)
- 4. Submit any MER or MER & overtime reimbursement requests on a "by event" basis

#### All FY2024 requests for reimbursement must be earned between October 1, 2023 to September 30, 2024.

WI CEASE is funded through the Drug Enforcement Administration (DEA), Domestic Cannabis Eradication/ Suppression Program (DCE/SP) via a Letter of Agreement with DCI. In turn, DCI is able to reimburse participants through this MOU. Therefore, there is not a CFDA number associated. Because reimbursements are funded by DEA, WI CEASE runs on the federal fiscal year. (reimbursements are typically paid via Automated Clearing House (ACH) on a quarterly basis).

\*Reimbursements received through WI CEASE apply to the federal per officer reimbursement limits\*
