AUTHORIZING CAPITAL FUNDING FOR THE PURCHASE AND INSTALLATION OF DANE COUNTY JAIL INMATE HOUSING UNIT LAUNDRY EQUIPMENT

Policy Analysis Statement:

Brief Description of Proposal -

The Sheriff's Office requests an increase to the 2016 Capital Budget in the amount of \$135,000 to fund upgrades to Dane County Jail inmate housing unit laundry facilities. Funding will provide for the purchase and installation of laundry equipment.

Current Policy or Practice -

Budget amendments require approval by the County Board.

Impact of Adopting Proposal -

Currently, inmate laundry equipment is provided contractually in the City-County Building, the Public Safety Building, and the Ferris Center and is utilized daily for laundering inmate personal garments, soiled clothing from intake and other areas of the jail, inmate worker uniforms, and other various laundry needs to maintain jail operations. Replacing existing laundry equipment will improve inmate living and sanitary conditions, improve operations, decrease energy costs associated with providing laundry service, increase safety and security, and address staff and inmate health concerns in the Dane County Jail.
