# 1. RFP Update

The Transportation RFP will reopen due to questions from vendors submitted to the Purchasing Department. This will allow bidders the opportunity to review the questions/answers and the opportunity to change their proposals. This delay will result in a June 1st, 2015 contract start date rather than the original May 1st, 2015 start date. Motion to approve June 1, 2015 start up date.

#### E. Presentations

#### NCST Grant Update

The grant from the National Center for Senior Transportation (NCST) is for testing ideas that will increase senior's use of public transportation. The Dane County NCST grant has 2 components. In the component in partnership with the Dane County Care Transition Team, seniors leaving the hospital will be counseled regarding transportation needs to their first follow up post hospital doctor visit. Unfortunately, the software tool was not initially reviewed by the hospital legal team. Upon review, the legal team decided the patients will be required to sign a formal authorization in order to participate. The discharge planning team concluded that this additional step would be too time consuming and interfere with efficiently discharging patients. This component of the NCST grant will be discontinued. The grant component in partnership with RSVP, bus-familiarization excursions for seniors which includes training on how to use the public bus, is moving forward. Four fun trips are scheduled. Bus Buddies are available to provide the public bus training during these social excursions. NCST is aware of the discontinuation of the hospital discharge component of the grant and this is acceptable because the 5 1/2 month grant was to simply try innovative ideas regardless of success or failure

#### 3. Employment Transportation Update

In 2014, 239 individuals received 31 day bus passes to assist with transportation while seeking employment. Approximately 74% of these individuals were available to participate in a follow up survey. Of the contacted individuals, 75% successfully found employment. This program has proven to be successful and will be continued in 2015.

# F. Reports to Committee

# **RSVP - Zutter**

The number of seniors requesting transportation assistance continues to grow. Due to limited drivers RSVP can not meet the transportation demands. The Oakwood Foundation has partnered with RSVP to assist in recruiting and hiring volunteer drivers. Their goal is to add 30 drivers to the volunteer driver pool. With additional volunteer drivers, RSVP would like to meet all the demands for medical rides and offer other types of trips for seniors.

# Proposed State Budget Effect on Non Emergency Medical Transportation (NEMT).

The proposed budget is vague as to how NEMT will be provided. It is possible that the Department of Health Services will contract with Medicaid providers to set up their own transportation for their clients. The positive to this type of transportation arrangement is that CMOs have an incentive to get clients to their doctor appointments. ACA research results indicate that attending doctor appointments and receiving prompt continuous care can prevent costly health issues.

The budget also suggests one CMO for the entire state. One large CMO would jeopardize client management through IRIS, SeniorCare, ADRC and Family Care.

#### Metro Transit - Martin.

The 2014 Metro Transit ridership reached 15 million rides. Metro Transit will be expanding service to the UW Clinic on East Terrace. This will be the last expansion based on present resources. Epic receives Metro Transit service and a discussion continues regarding the cost of this partnership. Martin attended one of the Public Hearings on the State Budget Proposal. The majority of speakers voiced concerns with the cut backs to UW and SeniorCare. It is important to promote transportation issues at these hearings. April 6, 2015 is the deadline to submit transportation issues online if one is unable to attend a public hearing.
