1) After meeting with Public Health Madison Dane Co., County Extension, and the Department of Land and Water Resources to discuss further, the committee decided to postpone any action on a SWIGG-like well study as a program evaluation topic. There are a number of logistical and cost concerns, as well as uncertainty re: what the SWIGG study counties will be able to do with the data within their jurisdiction. It makes sense to wait for the conclusion of that study and revisit the topic later.

2) The Committee directed Sup. Bayrd to work with County Board staff on scoping a program evaluation proposal for a study of specialty courts--specifically, OWI Court and Drug Court. The program evaluation scope and proposal will be brought to the Exec Committee at its September meeting.
