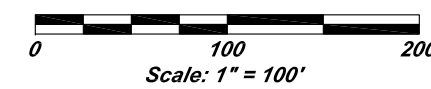


# PRELIMINARY PLAT OF HAPPY VALLEY ADDITION TO BRISTOL GARDENS

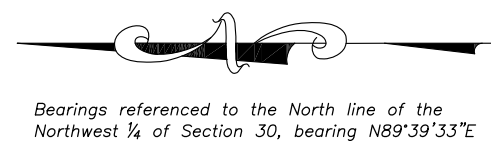
North 1/4 Corner

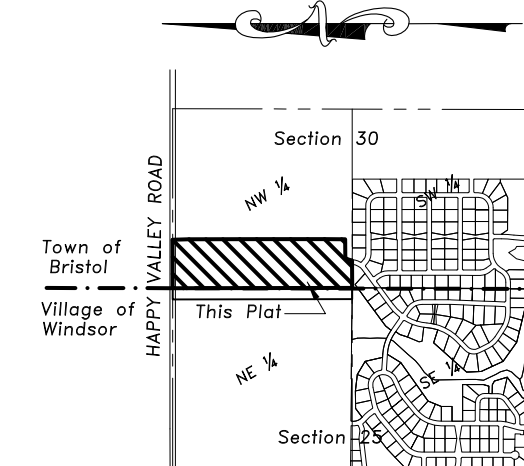
Part of the Northwest 1/4 of the Northwest 1/4 and part of the Southwest 1/4 of the Northwest 1/4, Section 30, T9N, R11E, Town of Bristol, Dane County, Wisconsin, described as follows: Beginning at the Northwest corner of said Section 30; thence N89°39'33"E, 716.78 feet along the North line of said Northwest 1/4; thence S00°27'05"E, 1457.89 feet; thence S00°01'08"E, 370.02 feet; thence S00°14'08"E, 83.82 feet; thence S00°34'53"E, 199.18 feet; thence S00°18'43"E, 532.31 feet to the North line of Bristol Gardens; thence S89°33'14"W, 718.90 feet along said North line to the West 1/4 Corner of said Section 30; thence N00°19'12"W, 2644.52 feet along the West line of said Northwest 1/4 to the said Northwest corner and the point of beginning; Containing, 1,899,994 square feet, or 43.62 acres.

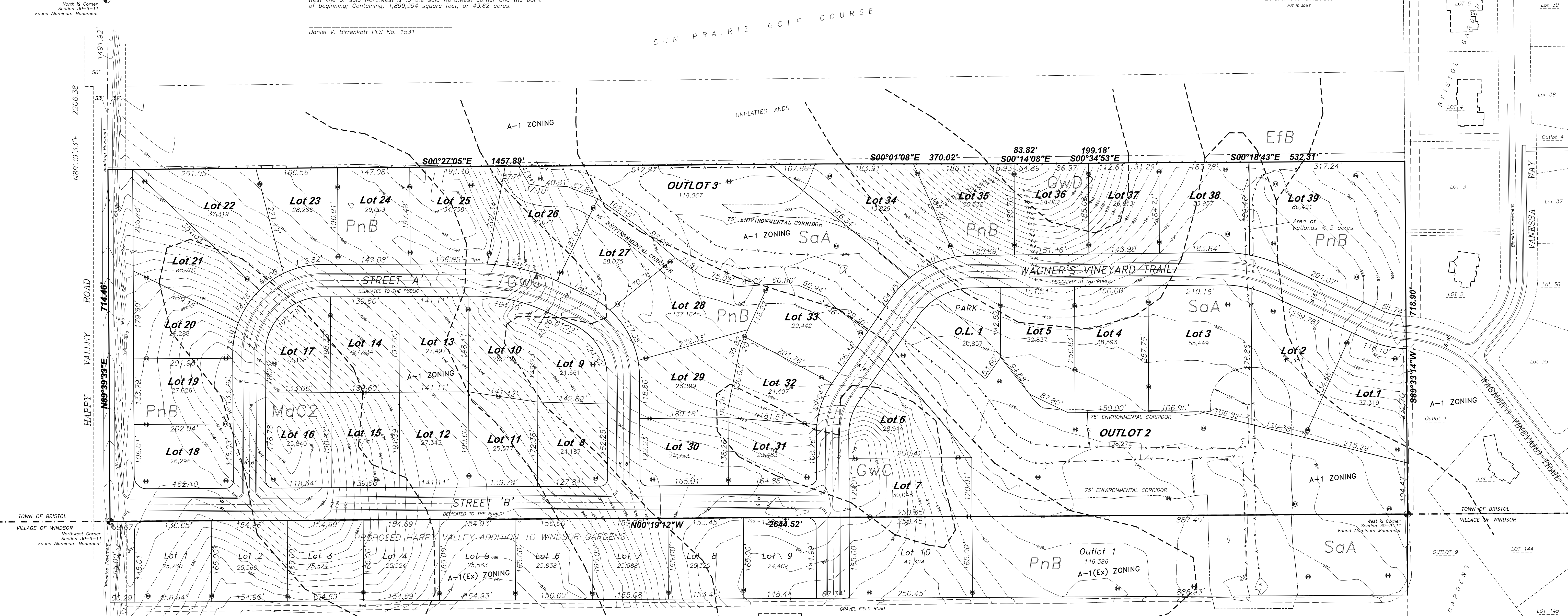

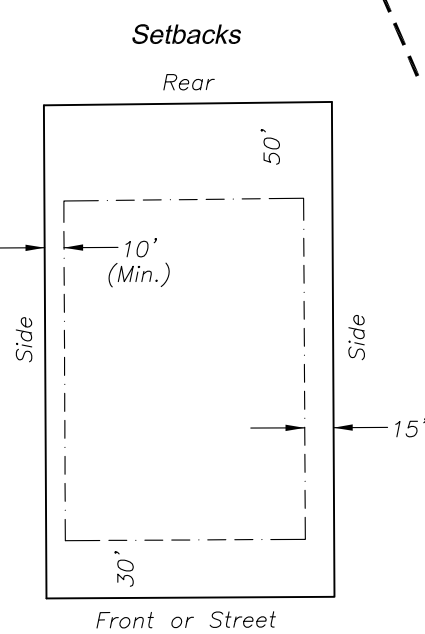
