C. Discussion Items

Dane County EMS Protocols

Active protocol recommendation link with QR code to be sent to EMS agencies to put sticker on book. Submissions to link can be reviewed monthly by MAS. Will allow group to consider making significant changes in a timelier manner with sticker updates for protocol book updates. Will have more thorough discussion about epi in cardiac arrest, both medical and trauma. Ask of any committee members to submit any data or suggestions regarding epi use for cardiac arrests. Will discuss at November meeting and come back at the January meeting with recommendation.

Luke Bryan Follow Up - Dr. Spigner

Dr. Spigner helped run field hospital for Luke Bryan concert; wanted to share info for future events. Planned for 20,000 people in a rural area. Being on the border of 2 counties caused some interoperability challenges. Role was to reduce transports to hospitals and strain on local EMS agencies. Saw 51 patients, 36 at field hospital. Saw a big surge once music began, about one patient every 3-4 minutes, which included 20% being pediatric patients. Important consideration is cell service availability to contact parents for consent to treat. 6 of 51 patients were transported. Expect more than 15 patients would have needed to be transported if field hospital was not available; may have exhausted local community response resources. Identified areas of improvement include security, rest and breaks, and shift length.

Buprenorphine in the ED

Peterson would like to learn what ED practice is regarding buprenorphine treatment and what follow up is made at discharge, i.e. therapy/support. Will work through EMS liaisons to connect with correct people in EDs to have that discussion. Would like to make sure best practice is followed at all facilities following buprenorphine treatment and connecting the patient to resources. Suggestion to have Sheriff's Office included since patients may be discharged from the hospital to the jail causing treatment to stop.

SCRTAC - Williams reports the Trauma Care Across the Continuum Conference will be on December 7th at Epic in Verona. Brochures will be distributed this week. RTAC will start doing trauma-related podcast for the region with first episode to be released in November. Active Shooter Incident Management training continues with goal of getting as many emergency response providers trained as possible. RTAC also made purchase of "patches" for EMS providers to use and help guide mid-axillary needle decompression. Will put this topic on November agenda to discuss protocol implications.

Meriter - Sefcik reports Meriter is starting 3rd phase of construction; should not interfere with patient transport.
