1. Work 'n Wheels Program

Southwestern Wisconsin Community Action Program, Inc.

Jeff Segebrecht

Segebrecht discussed the Work 'n Wheels program which started in 2001. The program provides eligible low-income workers, who live or work outside of public transit service areas, zero-interest car loans and family financial planning courses. It is a revolving loan fund. Recipients are required to ride-share where possible. Segebrecht explained there are 24 Counties in his program and he works directly with 7 Counties. Dane County's program started in 2014. To date there have been 62 loans to Dane County residents and this year there so far have been 11 loans given to residents in need. Southwest Community Actions operates the program from the loan application process to payment collection. This program allows families to get to and from work, and often leads to higher paying employment which results in a decrease in needed assistance programs.
