Dear Committee members,

Attached is the proposed 2016 schedule for the ZLR Committee meetings. Three conflicts were found with the scheduling of meetings on the standard dates. The Committee will need to decide on a date to hold the following meetings:

**August work meeting** – There is a conflict with the August 9<sup>th</sup> date due to the proposed requirements of recently introduced 2015 Ordinance Amendment 25. The ordinance would restrict County meetings on Election Days. August 9<sup>th</sup> is an election date.

Staff suggests that the ZLR Work meeting for August be on Monday, August 8<sup>th</sup> or Wednesday, August 10<sup>th</sup>.

**October work meeting** – There is a conflict with the October 11<sup>th</sup> date due to the observance of Yom Kipur.

Staff suggests that the ZLR Work meeting for October be on Monday, October 10<sup>th</sup> or Thursday, October 13<sup>th</sup>.

**November work meeting** - There is a conflict with the November 8<sup>th</sup> date due to the proposed requirements of recently introduced 2015 Ordinance Amendment 25. The ordinance would restrict County meetings on Election Days. November 8<sup>th</sup> is an election date.

Staff suggests that the ZLR Work meeting for August be on Monday, November 7<sup>th</sup> or Wednesday, November 9<sup>th</sup>.

AMENDING CHAPTER 7 OF THE DANE COUNTY CODE OF ORDINANCES,  
REGARDING PROHIBITING MEETINGS ON CERTAIN HOLIDAYS

The County Board of Supervisors of the County of Dane does ordain as follows:

ARTICLE 1. Unless otherwise expressly stated herein, all references to section and chapter numbers are to those of the Dane County Code of Ordinances.

ARTICLE 2. Section 7.51(6) is created to read as follows:

(6)(a) The Dane County Board or any committee thereof shall not meet on the following holidays: New Year's Eve, New Year's Day, Martin Luther King, Jr. Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, the Friday after Thanksgiving Day, Christmas Eve, Christmas Day, and from 60 minutes before to 60 minutes after Rosh Hashanah and Yom Kippur.

(b) The Dane County Board or any committee thereof shall not meet on the day of any general election for local, state or national offices, or referenda.

*[EXPLANATION: This amendment is intended to increase public participation in the governance of Dane County by avoiding scheduling meetings on dates of other significant events that may discourage attendance.]*
