4. PP&J WORKING SESSION - JAIL STUDY. PP&J members will work informally to
compile a list of questions regarding the 600+ page jail report. (45 minutes)

Discussion ensued and lists of questions were compiled.

Rusk: What are our options regarding mental health treatment? Where could mental health facility be located? Connected to jail, free standing, Badger Prairie?

Hook: David Wade will respond to questions previously asked.

Willett: Option #4 is not what Sup. Willett asked for. How much would it cost to remodel two floors in the City-County Building (CCB) without changing the exterior?

Hook: To create maximum security space or mental health space? Into what?

Willett: 38,000 sq. ft. on seventh floor, 42,000 sq. ft. on eighth floor. Public Safety Building (PSB) 3rd and 4th floors have a bed count of 408 in 60,000 sq. ft. Direct Supervision Model is the goal. It would seem we could get a number of beds in CCB with direct supervision model.

Hook: PSB was meant to house Huber. Now we house medium and maximum, which is not the same as what we are looking for in the modern direct supervision model. This is a mezzanine style. You would have to take a floor out of the CCB, so sq. ft. is not relevant.

Bayrd: Bayrd would like breakdowns of numbers/costs; line items for costs. If we buy nothing and all we have is the CCB, how much would it take to gut them and start over and what can or can't we get for it?

Rusk: We need a plan of what would happen to all people in the CCB in the interim.

Schauer: If we went to a greenfield space, what is the economic benefit of selling space at PSB?

McCarville: The PSB sounds like a money pit. What are all associated costs?

Rusk: What do we need to fix right away regarding health and safety and what are the costs?

Schauer: We have to know what it would cost to fix all of the most egregious issues.

Bayrd: We need a low-ball figure.

Rusk: What about "phasing?" 1) Health and safety on the sixth floor; 2) Mental Health with Huber.

Mahoney: We gave the consultants priorities and they gave us this answer: under the current philosophy of corrections we can't use seventh floor and the County Board has expressed the wish to close the Ferris Center (140 beds).

Schauer: If we need to build new, if we put it next to Badger Prairie and sold PSB real estate, can they make it under \$120 million?

Mahoney: Health and safety, special needs housing and work release. If these are priorities, you could pay less to get these.

Rusk: How much land do we need for new building? Rusk likes greenfield option because it saves \$58 million over 10 years in staff costs. We need more information on transportation costs to and from greenfield space within 10 miles of downtown.

Schauer: If original intent of PSB was Huber - return it to that use and use greenfield space for the other priorities instead, could we spend less?

Bayrd: Regarding the mental health services for those not in jail, is there an option to provide those services in the new plan?

McCarville: Regarding mental health - McCarville would like to see, in order to provide adequate services, we should identify costs that should be shared with others, such as mental health or medical services.

Schauer: This cannot be the project that solves all of the community's mental health problems. That would increase costs.

Mahoney: Could a mental health facility be created for the general population that could also be a facility to treat jail inmates?

Schauer: Regarding funding - need a discussion regarding where the funding can come from.

Bayrd: We need a breakdown on how much of the salary and other savings that would occur would eliminate union jobs.

Hook: That is in the report. "Food service workers," but there are additions of different classifications of AFSCME workers.

Willet: What happens to other functions of Consolidated Foods (seniors and Badger Prairie) would those costs be affected?

McCarville: What can we do to address immediate issues regarding health and safety?

Hook: Assessing value of property, etc. was not in the scope of their study. You could do a contract amendment to answer: 1) What are issues in CCB that we can address in the next couple of years? 2) How do we create special needs space? 3) How do we create Huber space? Now, give us the breakdown of how to phase it in over time.

Bayrd: I think we need to state our questions. Some can be answered by County staff like

property values.

Willett: We do need answers to the first batch of questions before we ask more.
MacKenzie will write up and circulate questions for input from committee members.

McCarville: Could we get a number on impact on staff if we move inmates during construction?
