D. Reports to Committee

Bauman updated the committee on the state grant process. Bauman reported that Joint Finance will meet on February 12, 2020 to take action on the state grant process. Bauman also reported that since last year, he has been working with the architect on finalizing the facility design plans, but that things were on hold for the moment. Bauman held a conference call today with the WCA about the Joint Finance possible action. WCA reported that there is an agreement to fund between \$80 to \$100 million dollars of the county facilities, but there is no clarity as to how the money will be appropriated. WCA believed that this funding structure would be approved by Joint Finance. Bauman reported that it does not appear that the Mendota Mental Health Institute expansion of MJTC will move forward at this time. In terms of next steps, the Building Commission must take it up next, but the Governor had previously said that all aspects need to move forward. Bauman also explained that he was working with Human Services on trying to develop numbers for potential revenue, expenses and savings. Committee members questioned Bauman about the updates presented.

E. Claims

The committee contemplates a closed session for purposes of conferring with legal counsel for the governmental body who will be rendering oral or written advice concerning strategy to be adopted with respect to litigation in which the County of Dane is or is likely to become involved. The authority for a closed session for such purposes is s. 19.85(1)(g), Stats. During the closed session, the committee may also conduct discussions relative to settlement demands and offers which for bargaining reasons require a closed session.
