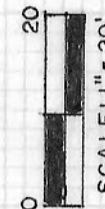
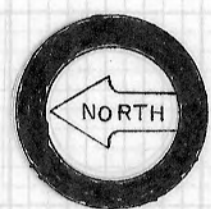


RUTLAND CENTER CEMETERY ANTHONY ADDITION

ALL DISTANCES SHOWN ALONG CURVES ARE CHORD MEASURE.

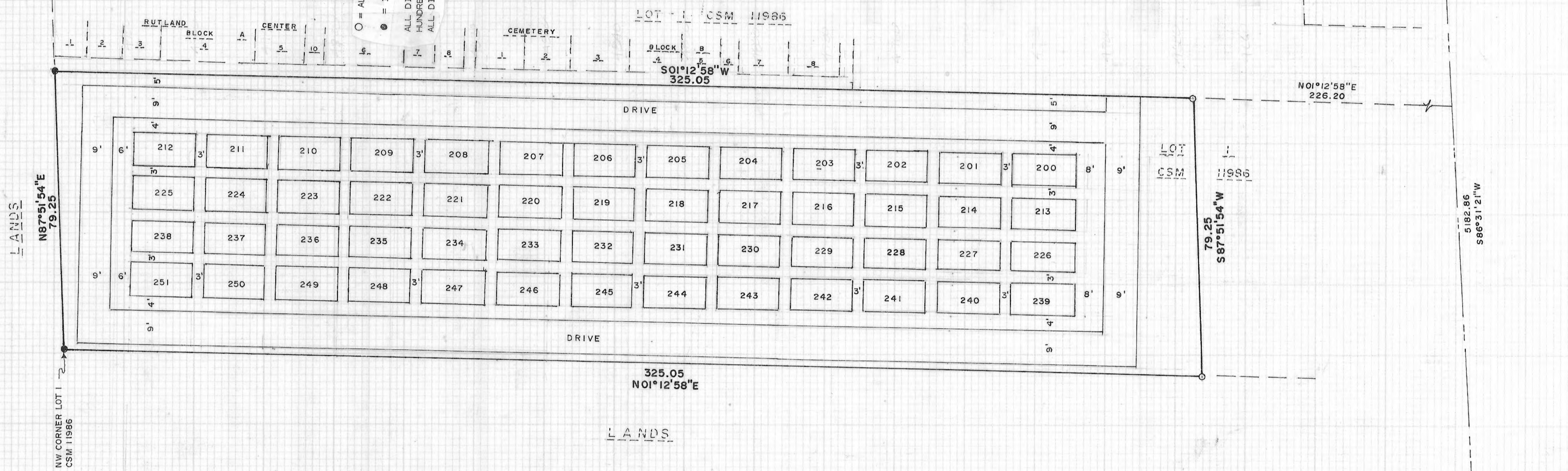

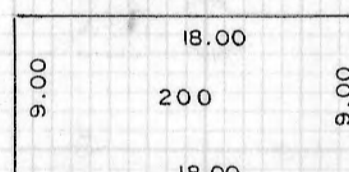

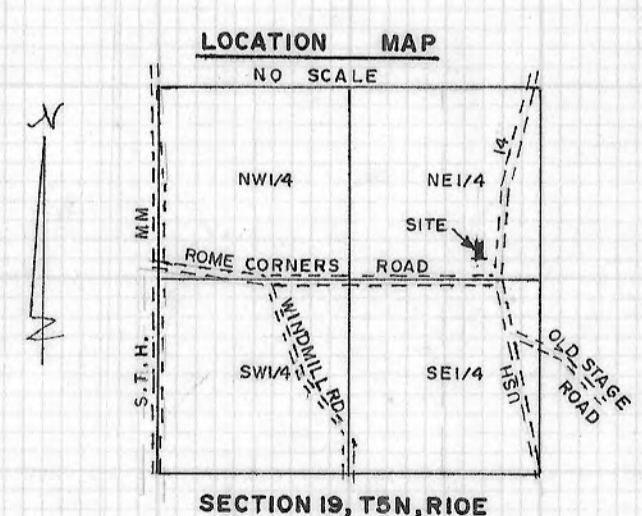
