- 3. Add \$10,000 GPR funding for non-English proficient case management services.
- 4. Add GPR funding annually equal to 5% of the total case management budget for the AAA Board and Department of Human Services staff to establish and operate a Special Project Award Program. (Funds would then be awarded to Senior Focal Points through an RFP process for one-time costs and with a carry-forward provision of unused funds to no more than the following year.)
