4 AMENDING CHAPTER 6 OF THE DANE COUNTY CODE OF ORDINANCES,
5 REGARDING FILLING SUPERVISORY VACANCIES

7 The County Board of Supervisors of the County of Dane does ordain as follows:
8

9 ARTICLE 1. Unless otherwise expressly stated herein, all references to section
10 and chapter numbers are to those of the Dane County Code of Ordinances.
11

12 ARTICLE 2. Section 6.07 is amended to read as follows:

13 **6.07 FILLING OF VACANCIES OCCURRING WITHIN A TERM.**

14 (1) Any vacancy in the office of county supervisor ~~occurring between the~~
15 ~~commencement of a term and December 31 of an even numbered year~~ shall be
16 filled by a temporary appointment by the county board chairperson within one
17 month of the vacancy subject to confirmation by the county board. A person so
18 appointed shall serve until his or her successor is elected and qualified ~~at a~~
19 ~~special election to be held concurrently with succeeding spring election.~~

20 (2) ~~Any~~ If a vacancy in the office of county supervisor occurs ~~spring after December~~
21 ~~31 of an even numbered year and before July 31 before June 1~~ of an odd-
22 numbered year ~~shall be filled as promptly as possible by the board shall order a~~
23 ~~special election to fill the vacancy as set forth in sub. (3).~~

24 (3) ~~Any vacancy in the office of county supervisor occurring after July 30 of an~~
25 ~~odd-numbered year shall be filled by temporary appointment by the county~~
26 ~~board chairperson within one month, subject to confirmation by the county board.~~
27 ~~A person so appointed shall serve the remainder of the expired term. If the board~~
28 ~~orders a special election during the period beginning on June 1 and ending on~~
29 ~~November 30 of an even numbered year, the special election shall be held~~
30 ~~concurrently with the succeeding spring election. If the board orders a special~~
31 ~~election during the period beginning on December 1 and ending on May 31 of the~~
32 ~~succeeding year, the special election shall be held on the Tuesday after the first~~
33 ~~Monday in November following the date of the order. Any person so elected shall~~
34 ~~serve for the remainder of the unexpired term.~~

35 (4) Any person interested in being appointed to a vacant office under sub. (1) ~~or~~
36 ~~(3)~~ shall submit nomination papers signed by at least 25 electors residing in the
37 supervisory district in which the vacancy occurs. The signatures on the
38 nomination papers may only be solicited by the person seeking the appointment.
39 Prior to such appointment, the county clerk shall publicly announce a two-week
40 solicitation period for submission of nomination papers and the declaration of
41 candidacy from interested residents of the district. After the close of the
42 application period, a public hearing shall be held in the supervisory district in
43 which the vacancy occurs, and persons interested in being appointed shall
44 attend. The chairperson shall not offer or promise appointment prior to the public
45 hearing. A person so appointed and confirmed shall hold office until a successor
46 is elected and qualified at the next regular election.
