The Department of Waste and Renewables reports the receipt of bids for the construction of Landfill Site No. 3, Phase 1 Cell 1, 4402 Brandt Road, Madison, WI ; RFB No. 326001. The bid has been awarded to low qualified bidder RG Huston Co., Inc. for the amount of \$11,823,115.00.
