#### A. Call To Order

#### **B.** Consideration of Minutes

A motion was made by Klehr to approve the 8/29/25 Executive Committee Minutes, seconded by Miquelon.

The motion was carried unanimously by a voice vote.

2. Approve September commission minutes

A motion was made by Miquelon to recommend the 9/8/25 Commission minutes for approval by the full commission, seconded by Klehr.

The motion was carried unanimously by a voice vote.

C. Action Items: Review Approve 2025 Cycle 2 Recommendations

#### 1. Approve short order grant awards budget

A budget limit of \$2,225 (up to 50% of total requests) for 2025 Cycle 2 Short Order grant awards was recommended by Dane Arts Staff.

A motion was made by Klehr to recommend the short order project grant maximum allocation of \$2,225 for approval by the full commission, seconded by Miquelon.

The motion was carried unanimously by a voice vote.

#### 2. Approve short order grant award allocations

Five eligible project grant applications were received. Funding requests and proposed awards are as follows:

- Clean Lakes Alliance Indigenous Ice Festival Displays and Events, Request: \$1,000, Proposed Award: \$500
- Madison Gamer Symphony Orchestra Madison Gamer Symphony Orchestra: Inaugural Concert, Request: \$1,000,
- Proposed Award: \$500
- Madison Theatre Guild Madison Theatre Guild's The Butter and Egg Man, Request: \$1,000, Proposed Award: \$500
- Sandra Schoen Sandra Schoen & Katherine Rosing (Paired Exhibitions), Reguest: \$950, Proposed Award: \$475
- Triangle Community Ministry Art for Life, Request: \$500, Proposed Award: \$250

A motion was made by Klehr to recommend the above proposed short order grant awards for approval by the full commission, seconded by Miquelon.

The motion was carried unanimously by a voice vote.

#### 3. Approve capital awards grant budget

The Commission determined that the Capital Grant budget is not to exceed 5% of total available funds in any given cycle.

%5 of the total 2025 Cycle 2 budget (\$92,262) allows \$4,863 for capital grant awards.

A motion was made by Miquelon to recommend the capital project grant maximum allocation of \$4,863 for approval by the full commission, seconded by Klehr.

The motion was carried unanimously by a voice vote.

#### 4. Approve capital grant award allocations

Commissioner Klehr recommended funding each of the seven eligible applications received at 30% of their request.

Capital grant requests and proposed awards are as follows:

- Arts & Literature Laboratory, Inc. Assistive Listening for ALL, Request: \$3,000, Proposed Award: \$900
- Create Waunakee, Inc. Durable Tents for Waunakee Artisan Market (WAM) Student/ Emerging Artists, Request: \$3,000, Proposed Award: \$900
- Dimensions In Sound & The Studio Orchestra Inc. Drum Kit Purchase, Request: \$1,430, Proposed Award: \$429
- Madison Area Potters Guild Madison Area Potters Guild 2025 Booth Project Grant, Request: \$1,380, Proposed Award: \$414
- Madison Metropolitan Schools Assistive Technology Department Artist in Everyone: Adapted Materials for Visual Art/Music Classes, Request: \$1,377, Proposed Award: \$413
- Oregon Community Foundation Oregon Community Foundation (dba OCA Media) video camera and audio equipment-August 2025, Request: \$3,000, Proposed Award: \$900
- Wisconsin Film Festival Equipment for 2026 Wisconsin Film Festival, Request: \$2,692.50, Proposed Award: \$808

A motion was made by Klehr to recommend the funding each of the seven capital grant applications at 30% of their request as outlined above for approval by the full commission, seconded by Miquelon.

The motion was carried unanimously by a voice vote.

#### 5. Acknowledge stipend amounts to panel reviewers

29 panelists reviewed grants during 2025 Cycle 2.

Each panelist is offered a \$100 honorarium for their time, bringing the total budget for grant panelist honoraria to \$2,900.

Honoraria is deducted from the cycle grant budget.

#### 6. Approve final grant pool dollar budget recommendation (action item)

After panelist honoraria (\$2,900), short order awards (\$2,225), and capital grant awards (\$4,764) are deducted from the cycle budget of \$97,262, \$87,373 remains for project grant awards.

A motion was made by Miquelon to recommend allocation of 87,373 for project grant awards for approval by the full commission, seconded by Klehr.

The motion was carried unanimously by a voice vote.

#### 7. Approve cycle two grant allocation recommendations

All scores skewed relatively high with scores ranging 63.7 - 99.4 out of 100 possible points, with a score average of 88.3.

The commission discussed awarding each application as outlined by the grant allocation formula, with the exception of the lowest scoring application which was recommended to receive the minimum award of \$500.

A motion was made by Miquelon to award all project grant applicants as outlined by the grant allocation formula, with the exception of a \$500 award to the lowest scoring applicant for recommendation to the full commission, seconded by Klehr.

The motion was carried unanimously by a voice vote.

#### D. Discuss Alternative Grant Award Allocation Ideas

#### 1. Seek idea starters

Since funding requests consistently exceed available funds, Chair Ritcherson proposed discussing various funding alternatives during the November commission meeting.

Chair Ritcherson presented funding alternative ideas for consideration including:

- 1. Only fund organizations with budgets under \$500,000
- 2. Only fund 3 disciplines per cycle
- 3. If applicants are awarded funds in one cycle they would have to wait until a set time before eligible to apply again
- 4. Only fund individual artists
- 5. Set a limit on the number of grant awards per cycle
- 6. Dane Arts commission determines the focus of the grant cycle
- 7. Only fund free events
- 8. Set a priority of increasing participants (to make art, music), or fund performances to increase appreciation of and for art, music
- 9. Request proposals for public art only
- 10. Dane Arts initiates our own public art project based on a specific theme, issue, etc. and issue an RFP
- 11. Change DAMA funding to direct, specific projects around the county

Curet suggested another option to only fund the top scoring applicants in each discipline.

Another suggestion included only funding limited-term projects.
