

1 **SUB 1 TO 2024 RES-030**

2 **ACCEPTING FEDERAL FUNDS FOR RENTAL ASSISTANCE EXPANSION AND AMENDING**  
3 **A CONTRACT**  
4 **DCDHS – HAA DIVISION**  
5

6 Dane County received additional Continuum of Care (CoC) funding from the federal agency of  
7 Housing and Urban Development (HUD) to increase rental assistance and expand case  
8 management services for a sponsor-based rental assistance program also funded by HUD CoC  
9 funds.

10  
11 The Dane County Department of Human Services (DCDHS) – Housing Access and Affordability  
12 Division (HAA) seeks to accept the additional award. Funding will be subcontracted to Housing  
13 Initiatives, Inc.  
14

15 The grant will enable Housing Initiatives, Inc. to expand its provision of case management and  
16 other supportive services for the tenants enrolled its federally funded sponsor-based rental  
17 assistance program. Tenants will have access to individual services to help them maintain  
18 housing stability and connect to other community resources they may need such as tenant  
19 education, financial management, employment and training, behavioral health services,  
20 transportation, and other mainstream benefits. Tenants eligible for services are those adults  
21 who have experienced unsheltered homelessness, who meet the definition of chronically  
22 homeless in HUD's Category 1 or 4, and were on the local Dane County Continuum of Care's  
23 (CoC) Coordinated Entry community prioritization list then moved into a Permanent Supportive  
24 Housing (PSH) program.

26 Chronically homeless is defined by HUD as individuals who have been homeless for at least a  
27 year, or multiple times over the last three years, and also experience serious mental illness,  
28 substance use disorders, and/or a physical disability.

30 **NOW, THEREFORE, BE IT RESOLVED** that the following expenditure account be created,  
31 80000 36626 (NEW) SUPPORTIVE SERVICES HUD, and

32 **BE IT FURTHER RESOLVED** that the \$440,333 revenue increase be credited to the County  
33 General Fund and transferred from the General Fund to the new expenditure accounts below in  
34 the DCDHS, and

35 **BE IT FURTHER RESOVLED** that account 80000 85267 HUD SHELTER PLUS CARE  
36 REVENUE be increased by an appropriation of \$440,333; and that account 80000 36626  
37 (NEW) SUPPORTIVE SERVICES HUD be increased with an appropriation of \$261,176; and  
38 that account 80000 36106 HOUSING ASSISTANCE EXPENSE be increased with an  
39 appropriation of \$179,157.

40 **BE IT STILL FURTHER RESOVLED** that the County Executive and County Clerk are hereby  
41 authorized and directed to sign the HUD agreement on behalf of Dane County, and

42 **BE IT FINALLY RESOVLED** that a \$440,333 amendment be approved for Housing Initiatives,  
43 Inc. (term of 01/01/2024-12/31/2024) and that the County Executive and County Clerk are  
44 hereby authorized and directed to sign the agreement on behalf of Dane County, and that the  
45 Controller is authorized to make payments:
