

Diversion Programs and/or Processes

Intercept One: Contact with law enforcement/emergency services, but divert from booking

Intercept Two: Post-Arrest/Arraignment - referred for booking, may be diverted without court arraignment; options at arraignment

Intercept Three: Court options/alternatives; options to continued confinement pending further court

Intercept Four: Community Reentry - options designed to divert individuals from continued confinement &/or shorten confinement

Intercept Five: Community Supports - designed to provide supports & resources to avoid reentry resulting from reoffending &/or revocation
