Todd Campbell asked about the timeline of the feasibility study and when it would be completed as opposes to when the RFP is ready. Asking if the two items will coincide. Supervisor Wegleitner asked clarifying questions about the timeline and what the drop-in center is intended for.

Conversation around what pieces are missing and what we are looking for from the applicants. Space is the biggest hurdle and it is not discussed in the RFP. There was a recommendation into putting thought into how funding into space and how it effects the timeline.
