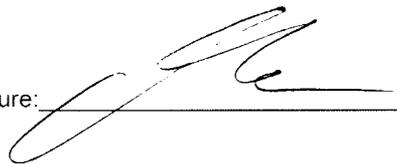

**AGREEMENT FOR THE RECONSTRUCTION CTH C  
IN THE CITY OF SUN PRAIRIE**

THIS AGREEMENT ("Agreement") is made and entered into by and between the County of Dane, a quasi-municipal corporation in the State of Wisconsin (hereinafter referred to as "COUNTY"), and the CITY of Sun Prairie; a municipal corporation in the State of Wisconsin (hereinafter referred to as "CITY")

**WITNESSETH:**

**WHEREAS** CITY and COUNTY have determined that a portion of CTH C requires reconstruction ("the Project"), which will require contributions from CITY and COUNTY; and

**WHEREAS** the COUNTY has received Local Road Improvement funds to cover certain project costs up to \$480,875; and

**WHEREAS** the remaining costs of the Project will be financed by a combination of COUNTY and CITY funds as well as Village of Windsor funds governed by a separate agreement; and

**WHEREAS** CITY has entered into a separate financial agreement with the Town of Burke whereby COUNTY will bill CITY for work attributable to the Town of Burke; and

**WHEREAS** pursuant to Section 66.0301, Wis. Stats., CITY and COUNTY wish to formalize arrangements for the local share of Project's cost; and

**NOW, THEREFORE**, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is acknowledged by each party for itself, CITY and COUNTY do agree as follows:

1. The Project shall consist of reconstruction of CTH C from STH 19 to Stonehaven Drive to an undivided urban four-lane roadway with curb and gutter, and the addition of an off-road pedestrian/bicycle facility including upgrades at the crossing of STH 19. The portion of CTH C within the Project area that is already four-lane divided urban roadway will only be resurfaced. COUNTY will also resurface, and add paved shoulders on CTH C from Stonehaven Drive to Egge Road at no expense to CITY.
2. COUNTY and CITY agree to joint financial participation in those construction costs for the Project, as set forth in this Agreement and the Dane County Dept. of Public Works, Highway and Transportation's Policy on Joint Projects with Municipalities.
3. The Project will be completed in 2016.

4. CITY has obtained a Temporary Limited Easement from QBE Americas, Inc., to work within designated portions of the Project area during construction. COUNTY shall adhere to the requirements as set forth in the Temporary Limited Easement.
5. The cost share is as shown in Attachment A.
6. Routine maintenance of the detention basin as shown in Attachment B will be the responsibility of COUNTY in odd-numbered years. CITY will be responsible for routine maintenance in even-numbered years. Routine maintenance is defined as annual mowing and removal of brush within the limits of the detention basin as shown in Attachment B. as All other maintenance costs including, but not limited to, scraping silt from the bottom of the basin will be equally shared between, CITY and COUNTY. Scheduling of this work will be mutually agreed upon by CITY and COUNTY.
7. CITY shall reimburse COUNTY within 60 days after invoices are received by CITY.
8. During the term of this Agreement, CITY and COUNTY, each for itself, agree to abide by its own equal employment and nondiscrimination policies and affirmative action plan and, in doing so, to make all employment and service related decisions without regard to age, race, ethnicity, religion, color, gender, disability, marital status, sexual orientation, national origin, cultural differences, ancestry, physical appearance, arrest record or conviction record, military participation or membership in the national guard, state defense force or any other reserve component of the military forces of the United States, or political beliefs and to provide equal opportunity including but not limited to the following: employment, upgrading, demotion, transfer, recruitment, advertising, layoff, termination, training, rates of pay, or any other form of compensation. CITY agrees to post in conspicuous places, available to all employees and applicants for employment, notices setting forth the provisions of this Agreement as they relate to affirmative action and nondiscrimination. This listing of prohibited bases for discrimination shall not be construed to amend in any fashion state or federal law setting forth additional bases, and exceptions shall be permitted only to the extent allowable in state or federal law.
9. Each party shall be responsible for the consequences of its own acts, errors, or omissions and those of its employees, boards, commissions, agencies, officers, and representatives and shall be responsible for any losses, claims, and liabilities which are attributable to such acts, errors, or omissions including providing its own defense. In situations including joint liability, each party shall be responsible for the consequences of its own acts, errors, or omissions and those of its employees, agents, boards, commissions, agencies, officers and representatives. It is not the intent of the parties to impose liability beyond that

imposed by state statutes. The obligations of the parties under this paragraph shall survive the expiration or termination of this Agreement.

10. This Agreement may only be amended in writing upon agreement by both parties.
11. Each party warrants for itself that it has complied with all necessary requirements to execute this Agreement and that the person executing this Agreement on its behalf is authorized to do so.
12. The parties may evidence their agreement to the foregoing upon one or several counterparts of this instrument, which together shall constitute a single instrument.

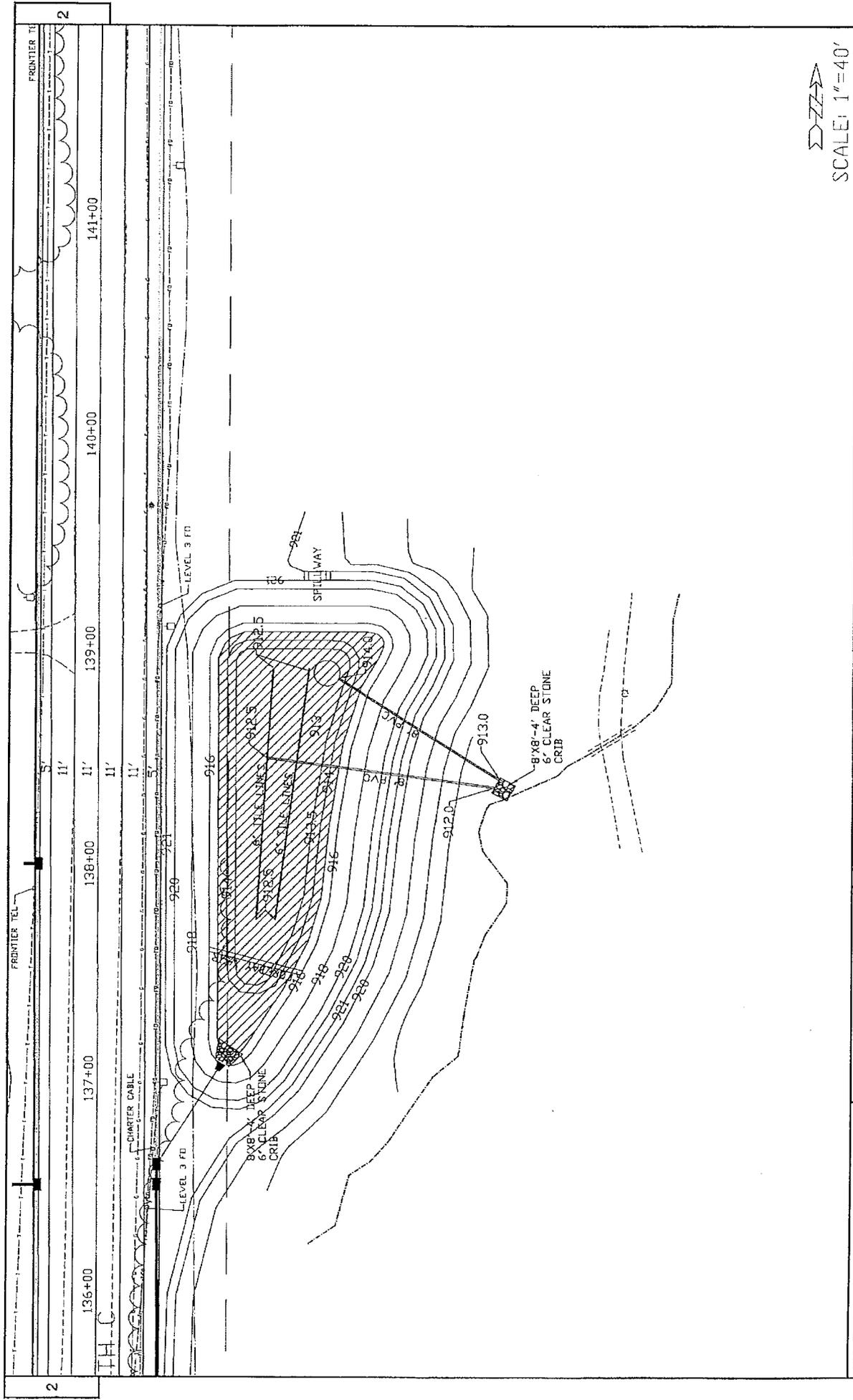
