Brief Description of Proposal -

DCDHS purchases pharmaceutical products for residents of Badger Prairie Health Care Center from PP Acquisition Company LLC dba Omnicare of Madison. These products include prescription medications, over-the-counter medications and supplies, and other medical supplies and vaccines. The level and type of products provided fluctuates dependent on patient need. Actual 2018 utilization has been higher due to a higher Medicare Part A resident census

Current Policy or Practice -

Contracts over \$100,000 require County Board approval.

Impact of Adopting Proposal -

This resolution authorizes increasing the Medicare Part A Pharmacy expense account by a total of \$20,000, with a corresponding increase in the Medicare Part A Room & Board revenue account. This would bring the contract total to \$109,500.
