**AUTHORIZING AN AGREEMENT TO ACCEPT GRANT FUNDING FOR BREACHING
INSTRUCTOR TRAINING**

The Homeland Security (HS) – Wisconsin Emergency Management (WEM) Grant Program is providing \$1,600 funding to the Sheriff's Office to receive certified mechanical breaching instructor training; Grant Number 2019-HSW-02B-12337, funding is available January 8, 2021 through September 3, 2021.

This grant supports the Aligned Law Enforcement Response Team initiative by providing funding for Sheriff's Office staff to attend training to become a certified mechanical breaching instructor. This comprehensive training provides working knowledge of breaching tools and techniques for entries through barriers in active shooter events, barricaded hostage situations, and for citizen/officer rescue.

NOW, THEREFORE, BE IT RESOLVED that the Sheriff's Office is authorized to accept \$1,600 in the 2021 Budget from HS WEM to attend certified mechanical breaching instructor training, and on behalf of the County of Dane, the County Executive is authorized to execute an agreement embodying the above provisions; and

BE IT FURTHER RESOLVED that \$1,600 is appropriated as additional 2021 revenue in the Sheriff's Office, Field Services Division, TRT Training Grant Revenue (SHRFFLD NEW) and is credited to the General Fund; and

BE IT FINALLY RESOLVED that \$1,600 is transferred from the General Fund to 2021 Budget, Sheriff's Office, Field Services Division, TRT Training Grant Expense (SHRFFLD NEW).

Grant funds will be used by the Dane County Sheriff's Office, and other member teams of the Aligned Law Enforcement Response Teams (ALERT) Special Weapons And Tactics (SWAT) teams to attend training out of state at a well-established training facility in order to become certified mechanical breaching instructors. The training is for agencies that need an instructor that will, in turn, instruct his/her team and host training for other teams. The training provided will improve public safety in Wisconsin by having standardized instructors for forcible entry into vehicles and structures, should the need arise for officer/citizen rescue, active shooter events, barricaded criminal suspects, and hostage situations. Each regional ALERT tactical team will be provided funding that will allow for course registration, lodging expenses, travel and meals for the four day course.

6. Upon completion of the training, the instructors must conduct training for their regional partners (non-ALERT) within one-year of the close of this grant.

Agreement Articles for Federal Fiscal Year 2019 Homeland Security Awards

Article I – Summary Description of Award

The purpose of the FY 2019 HSGP is to support state and local efforts to prevent terrorism and other catastrophic events and to prepare the Nation for the threats and hazards that pose the greatest risk to the security of the United States. The HSGP provides funding to implement investments that build, sustain, and deliver the 32 core capabilities essential to achieving the National Preparedness Goal of a secure and resilient Nation. Among the five basic homeland security missions noted in the DHS Quadrennial Homeland Security Review, HSGP supports the goal to Strengthen National Preparedness and Resilience. The building, sustainment, and delivery of these core capabilities are not exclusive to any single level of government, organization, or community, but rather, require the combined effort of the whole community. This HSGP award consists of State Homeland Security Program (SHSP) funding in the amount of \$4,077,500. This grant program funds a range of activities, including planning, organization, equipment purchase, training, exercises, and management and administration across all core capabilities and mission areas.

Article II - Acceptance of Post Award Changes
