AMENDED AGREEMENT FOR THE RECONSTRUCTION OF CTH MN FROM LONG STREET TO USH 51 IN THE VILLAGE OF MCFARLAND

1. Dane County and the Village of McFarland previously entered into an agreement "Agreement for the Design, Reconstruction and Jurisdictional Transfer of CTH MN in the Village of McFarland" ("Original Agreement") which was fully executed on April 17, 2018.
2. This amendment to the Original Agreement increases Dane County's total obligations from \$570,000 to \$576,492.76.
3. This amendment to the Original Agreement increases Village of McFarland's total obligations from \$801,000 to \$1,096,098.53.
4. All other items of the Original Agreement, not changed by this Agreement, shall remain in full force and effect.

IN WITNESS WHEREOF, the parties have executed this agreement to the foregoing upon one or several counterparts of this instrument, which together shall constitute a single instrument.
