**AUTHORIZING AN AGREEMENT TO ACCEPT GRANT FUNDING FOR TACTICAL MEDICAL TRAINING**

**Policy Analysis Statement:**

Brief Description of Proposal -

The Wisconsin Department of Military Affairs (DMA), Homeland Security (HS), Wisconsin Emergency Management (WEM) Grant Program is providing \$1,500 funding to the Sheriff's Office for tactical medical training; Grant Number 2019-HSW-02B-12471, funding is available July 19, 2021 through November 12, 2021.

Current Policy or Practice -

Acceptance of grant funding requires County Board approval.

Impact of Adopting Proposal -

Tactical Emergency Medical Support (TEMS) is the provision of preventative, urgent, and emergent medical care during high-risk, extended duration, and mission-driven law enforcement special operations. The ability of TEMS providers to develop medical threat assessments, render immediate medical care in austere environments, and provide logistical support furthers the health and safety of the public and law enforcement personnel and reduces the incidences of injury, illness, disability and death associated with tactical operations.
