**URBAN WATER QUALITY GRANT AWARD**

**Policy Analysis Statement:**

Brief Description of Proposal -

The Dane County Urban Water Quality Grant Program is included in the County Budget to improve the quality of urban stormwater runoff entering county lakes, rivers and streams, increase public awareness of urban water quality issues, and provide public education for urban stormwater quality improvement practices. The Land & Water Resources Dept. recommends \$615,000 in funding for the City of Madison East Towne Pond Reconstruction project.

Current Policy or Practice -

Urban Water Quality Grant Awards require County Board approval.

Impact of Adopting Proposal -

The project goals are to be achieved through the construction of best management practices that will provide efficient, cost-effective treatment of urban runoff. The grant awards are contingent on the County and project sponsor entering into a grant agreement that will specify the program requirements and applicable grant conditions for each project. The grant funds are currently available in the Legacy Fund.
