Conference Room 1 is adjacent to the main lobby at the far north end of the terminal, just past baggage claim.

There will be an optional, in-person bus tour of the outside grounds to begin promptly at 4:30 P.M., and an inside tour following the adjournment of the PW&T Committee Meeting. There will be no business conducted on either tour. Those interested in participating are requested to assemble in Conference Room 1 prior to the tour's departure.
