- 6. Outdoor lighting shall be dark sky compliant on a switch or short-timed motion light at the door of the studio.
- 7. Outside loudspeakers are prohibited.
- 8. Signage at the roadside shall not be permitted.
- 9. A sink and toilet may be installed in the accessory building. A kitchen sink or a bathroom with a bath/shower is prohibited.
