The Youth Commission plans to look in more detail at the data gathered on guns and school safety on the Dane County Youth Assessment (DCYA.)

Benson will review DCYA data across demographic groups and will share this out in the next meeting.

Megan Meinen will send out the full DCYA survey to Youth Commission members to review.

The Commission wishes to look into ways to partner with organizations doing work in this area such as Focused Interruption, Public Health Violence Prevention group, allies with BIPOC youth, Alderman Glenn, etc. There was discussion of partnering with law enforcement, including Captain Shannon Blackamore of the Madison Police Department.

The group reviewed school survey climate results from Waunakee High School.

The Youth Commission will consider ways to disseminate DCYA results in the community, such as joining with another summit or planning a DCYA event like Voice of Our Youth in 2018. The group discussed communication needs around planning an event.
