 - a. Walking Iron Wildlife Area Restoration Project

Kwitek gave an overview of a 77-acre wildlife habitat restoration project that will soon be taking place at Walking Iron Wildlife Area. The vision is for a mix of woodland, oak savanna, grasslands, and early successional habitats. Restoration activities will include tree harvest, invasive species control, seeding, and follow up maintenance with mowing, selective herbicide, and prescribed fire. Wildlife intended to benefit from restoration of these habitats include: wild turkey, white tailed deer, Eastern blue birds, red-headed woodpeckers, ruffed grouse, Bobwhite quail, woodcock, and native pollinators.

Neighbors and stakeholders were notified of the project and invited to a site meeting that will be held on Monday, August 17, 2015 at 6:00 PM at Walking Iron Wildlife Area.

b. Door Creek Watershed and Natural Resources Projects

Marsh summarized the draft Door Creek Watershed Plan that the Office of Lakes and Watersheds has developed. LWRD staff will provide an overview of the plan at the next EANR meeting that will be held on Tuesday, August 18, 2015. Park Commission members are invited to attend the meeting.

c. 2016 Budget

Commission members discussed the Parks budget needs that were identified last year and areas of concern. There was a request for staff to give an overview of the 10 year workplan for parks planning and development projects that was developed by staff for the first time this year.

d. Conservation Fund Grant Program Update

Kwitek indicated that due to her move to the Parks Division and taking on more planning and development project management activities, the Conservation Fund Grant Program will be managed by Jan Zimmermann in the future. The Natural Heritage Land Trust submitted two grant applications that will likely be taken up at the second Park Commission meeting in September.

Marsh gave an overview of the Volunteer Appreciation Picnic that will be taking place at on August 20, 2015 at Badger Prairie County Park.
