AUTHORIZING A CONTRACT TO PROVIDE A FREEWAY SERVICE TEAM FOR THE WISCONSIN DEPARTMENT OF TRANSPORTATION (WI DOT)

Policy Analysis Statement:

Brief Description of Proposal -

Request approval to enter into a contract to provide funding for the Freeway Service Team for the USH 12/14/18/151 corridor in Dane County. The term of the contract is from July 1, 2024 to June 30, 2025. Estimated expenditures and revenues, not to exceed \$320,000, will be handled through the 2024/2025 budget process. This project provides funding for positions 2413 and 2414, contingent upon continued financial support from the WI DOT.

Contracts in excess of \$100,000 require County Board approval.

Impact of Adopting Proposal -

Approval of the contract will allow the Dane County Sheriff's Office, Freeway Service Team, to locate, respond, and clear traffic incidents quickly. Clearing traffic incidents quickly reduces congestion, provides efficient traffic flow, reduces delays, and reduces the chance of traffic accidents.
