F. Presentations

1. Groundswell Conservancy - Jim Welsh

Mr. Welsh presented information on a Groundswell project to preserve 84 acres of wetland and savannah area along Six Mile Creek, west of Waunakee. It's across the road from Ripp Park and just downstream from the DNR's Waunakee Marsh. The property provides a great opportunity to protect a key flood storage area just prior to the creek winding its way through the Village of Waunakee. The property also supports a seasonal snowmobile trail and offers the opportunity for hiking trails.

2. The Prairie Enthusiasts - Dave Wilken for Prairie Enthusiasts

Dave Wilken discussed how he wanted to preserve a 4.5 acre prairie area that he established in 1995 and contains an amazing array of native forbs and grasses. His property is adjacent to lands owned and maintained by the Prairie Enthusiasts as part of the Pleasure Valley Conservancy in the Town of Vermont. The Prairie Enthusiasts are seeking stewardship and county grants to preserve the prairie.

G. Reports to Committee

1. Friends of Anderson Park Tractor Purchase

Marsh stated that the Friends of Anderson County Park were successful in the fundraising efforts to purchase a compact utility tractor. They raised over \$23,000 to make the purchase. The tractor will be used to support their ongoing work, developing and maintaining Anderson County Park. The tractor will also support the Friends' agricultural initiatives to support local agricultural and food pantry needs.

2. Foundation for Dane County Parks

LUNNEY noted that the name change for the foundation is now final – Foundation for Dane County Parks. LWRD and Parks are evaluating a draft MOU between the foundation and Dane County. The foundation has also been working on a grant program to support the goals of the Friends of Dane County Parks Endowment. A committee is working with park staff on the grant application language and on the amount of resources that will be available. At the Volunteer Summit, March 9th, the grant program will be announced. The foundation will also be surveying the park staff, friends groups, and volunteers to see what other needs they have. The foundation will then set goals to see what can be done to meet those priority needs. The foundation is also working to create accessible fishing piers throughout the county. This campaign will kick off later this spring. Information on the Accessible Pier Program will be displayed at the Parks booth at the upcoming Fishing Expo on February 22nd -24th.

Chair LUNNEY requested a change of agenda order to consider "Item J. Public Comment on Items not on the Agenda" next. There was no objection.

Jim Welsh commented on a flood mitigation option that was contained in the 2018 Yahara Chain of Lakes Flooding – Technical Report. Welsh wanted Parks Commission to be aware that there is a concern where a possible pumping route has been identified through the Waubesa Wetlands, a State Natural Area.
