**AUTHORIZING AN AGREEMENT TO ACCEPT GRANT FUNDING FOR THE PURCHASE
OF VIDEO MESHING EQUIPMENT**

The Homeland Security (HS) – Wisconsin Emergency Management (WEM) Grant Program is providing \$45,000 funding to the Sheriff's Office to purchase video meshing equipment; Grant Number 2019-HSW-02A-12048, funding is available August 28, 2020 through December 31, 2020.

This grant supports the Aligned Law Enforcement Response Team initiative by providing funding to purchase and install a video meshing system to provide high quality, easy to use, cost-effective, rapidly deployable wireless surveillance solutions to law enforcement first responders. Video meshing equipment works with existing analog and digital (IP) specialty video equipment including bomb robots, thermal imagers, negotiator phones, and have self-contained power requiring no pre-existing communication infrastructure.

NOW, THEREFORE, BE IT RESOLVED that the Sheriff's Office is authorized to accept \$45,000 from HS WEM to purchase video meshing equipment, and on behalf of the County of Dane, the County Executive is authorized to execute an agreement embodying the above provisions; and

BE IT FURTHER RESOLVED that \$45,000 is appropriated as additional revenue in the Sheriff's Office, Field Services Division, Video Meshing Equipment Revenue (SHRFFLD NEW) and is credited to the General Fund; and

BE IT FURTHER RESOLVED that \$45,000 is transferred from the General Fund to Sheriff's Office, Field Services Division, Video Meshing Equipment (SHRFFLD NEW); and

BE IT FINALLY RESOLVED that all unexpended funds and unrecognized revenues from the above referenced budget account lines are carried forward from the 2020 budget to the 2021 budget period.



2. Emergency response capabilities developed using these grant funds must be made available to other emergency response agencies regionally, as may be required for incident response purposes.
3. Equipment shall be maintained and available to use as intended by the grant for the duration of its useful life. The sub-recipient is required to maintain proper equipment records. Sub-recipient seeking to dispose, or transfer ownership of equipment must contact Wisconsin Emergency Management (WEM) Homeland Security Staff to obtain the Homeland Security Equipment Disposition Form, and further directions. If approved, the sub-recipient must maintain records of any equipment disposal or transfer of ownership. Any proceeds from the sale of equipment at or near the end of its useful life will be considered program revenue and must be reinvested into eligible homeland security expenses.



Agreement Articles for Federal Fiscal Year 2019 Homeland Security Awards

Article I – Summary Description of Award

The purpose of the FY 2019 HSGP is to support state and local efforts to prevent terrorism and other catastrophic events and to prepare the Nation for the threats and hazards that pose the greatest risk to the security of the United States. The HSGP provides funding to implement investments that build, sustain, and deliver the 32 core capabilities essential to achieving the National Preparedness Goal of a secure and resilient Nation. Among the five basic homeland security missions noted in the DHS Quadrennial Homeland Security Review, HSGP supports the goal to Strengthen National Preparedness and Resilience. The building, sustainment, and delivery of these core capabilities are not exclusive to any single level of government, organization, or community, but rather, require the combined effort of the whole community. This HSGP award consists of State Homeland Security Program (SHSP) funding in the amount of \$4,077,500. This grant program funds a range of activities, including planning, organization, equipment purchase, training, exercises, and management and administration across all core capabilities and mission areas.

Article II - Acceptance of Post Award Changes

In the event FEMA determines that changes are necessary to the award document after an award has been made, including changes to period of performance or terms and conditions, recipients will be notified of the changes in writing. Once notification has been made, any subsequent request for funds will indicate recipient acceptance of the changes to the award.
