G. Reports to Committee

1. Urban Water Quality Grant Program Update

Balousek noted that 53 projects have been funded by this program since its inception in 2005. In 2017 there will be \$1.5 million in new funding available, plus \$300-400,000 in carry forward. The grant scoring criteria for 2017 will be available in January or February, and Balousek offered to seek Commission input on those. LWRD staff hope to seek grant applications beginning in the first quarter of 2017. Commission members expressed an interest in making grants available to municipalities for leaf management practices.

2. Evaluation of Manure Storage Capital Projects in the Yahara River Watershed - Status

POWER encouraged members to review the manure storage report, and to send questions and comments to her in advance of the January 19 presentation by Dr. Rebecca Larson to the quarterly meeting of natural resources committees and commissions. Porter, who also is a member of the research team, shared several key points for members to pay attention to while reading the report.

3. Commission Equity Statement and Priorities

Any questions or suggestions for the final equity statement and priorities should be sent to Susan Jones. This will be an action item at the January 12 Commission meeting.

4. Community Engagement Report

From her November-December written report, Sandford highlighted the new Dane Waters website, Ripple Effects branding, recent Watershed Network Gatherings, and the interactive watershed model to be installed at the zoo.

5. Chloride Update

Susan Jones, Sandford, and Emily Jones all participated in the report of the recent high level of Wisconsin Salt Wise accomplishments. Salt Wise partners have been collaborating to produce media and watershed group toolkits; short videos highlighting different audiences and their actions to reduce salt use; morning TV show appearances; 2017 county funding for development of application rate standards for driveways, parking lots and sidewalks; and mugs prompting proper salting amounts and scatter pattern. Dane County water softener efficiency upgrades and upcoming homeowner outreach are additional efforts being worked on.

6. Shoreland Zoning Ordinance

Susan Jones said that Dane County has been notified of ordinance changes required to bring it into compliance with recent changes in state law. She will send relevant background to members.
