

**Dane County Board of Supervisors  
Amending Chapter 10 of the Dane County Code of Ordinances  
Zoning Map Amendment Petition 11630**

Dane County Board of Supervisors does ordain as follows:

The Zoning Districts Maps as referenced under Dane County Code of Ordinance Section 10.200(4) shall be amended as follows:

**Town Map:** OREGON                      **Location:** Section 15

**Zoning District Boundary Changes**

**RR-4 to RR-8**

Lot 1 of Certified Survey Map 5846 (Vol. 27, Pages 284-285) in the Northwest ¼ of the Southeast ¼ of Section 15, Town 5 North, Range 9 East, Town of Oregon, Dane County, Wisconsin, bounded and described as follows: Commencing at the South ¼ corner of said Section 15; thence N00°50'06"E, 1848.20'; thence S89°11'40"E, 110.81' to the point of beginning; thence S89°11'40"E, 463.21' to the Westerly right of way line of Glenway Road; thence S24°40'14"E along said right of way line, 212.97'; thence S26°45'01"E along said right of way line, 226.16'; thence N89°12'19"W, 659.36'; thence N00°47'41"E, 392.73' to the point of beginning.

**FP-35 to RR-8**

That part of the Northwest ¼ of the Southeast ¼ of Section 15, Town 5 North, Range 9 East, Town of Oregon, Dane County, Wisconsin, bounded and described as follows: Commencing at the South ¼ corner of said Section 15; thence N00°50'06"E, 1328.33' to the SW corner of the NW ¼ of the SE ¼ of Section 15 and the point of beginning; thence N00°50'06"E, 519.87'; thence S89°11'40"E, 110.81'; thence S00°47'41"W, 392.73'; thence S89°12'19"E, 696.58' to the centerline of Glenway Road; thence S26°45'01"E along said centerline, 121.34' to the South line of the NW ¼ of the SE ¼ of Section 15; thence N89°30'37"W, 864.09'; to the point of beginning.

**CONDITIONAL ZONING**

Conditional zoning is hereby imposed pursuant to Section 10.101(8)(d) of the Dane County Code of Ordinances. The rezoned area shall be subject to the following conditions.

**CERTIFIED SURVEY REQUIRED**

The above listed description/s is/are intended to describe land for which a certified survey map will be prepared for approval and recorded. Within 90 days of rezoning approval by Dane County, a *final* certified survey map that describes the land to be rezoned shall be prepared in accordance with all applicable provisions of Chapter 236 Wisconsin Statutes and Chapter 75 Dane County Code of Ordinances, and submitted to the Dane County Zoning Division. Upon submission of the final certified survey map, the Zoning and Land Regulation Committee, or its authorized representative, shall, within 30 days, approve,

approve conditionally, or reject the certified survey map. **Failure to submit the final certified survey within the 90 day period and/or failure to record the survey with the Dane County Register of Deeds will cause the rezone to be null and void. Two copies of the recorded survey shall be submitted to Dane County Zoning.**
