AUTHORIZING EXECUTION OF ELECTRICAL SERVICE AGREEMENT FOR PURCHASE OF BACKUP GENERATION SERVICE AT THE DANE COUNTY REGIONAL AIRPORT

Policy Analysis Statement:

Brief Description of Proposal -

Dane County Regional Airport staff has negotiated a successor agreement with Madison Gas & Electric for backup electrical generation service to take effect at the expiration of an existing agreement. MG&E provides a 900 KW generator which acts as a backup in supporting essential electric service at the airport.

Current Policy or Practice -

The Airport and MG&E are presently parties to a contract under which MG&E supplies a 900 kilowatt generator to provide essential electric power at the Airport in the event of a failure or malfunction of MG&E's power grid.

Impact of Adopting Proposal -

The airport will continue to function with backup for essential electric service providing a safe and secure environment for the travelling public at the airport.
