Authorization to Enter into Contract with and Distribute funds to Selected Applicants from the 2025 Violence Prevention & Intervention Grant Program RFP

Public Health-Madison and Dane County (Public Health) released the 2025 Violence Prevention & Intervention Grant Program Request for Proposals (RFP) to seek applicants providing innovative violence prevention programming and/or providing program services that can contribute to Public Health's violence Intervention service provider network.
