As for the traffic concern, most likely it would be no more than an event at the Barrel Inn (horse pull, poker run, a busy Friday night). The residence in question has a long driveway for angle parking (in addition to the bar parking lot). Many wedding's today offer/provide safe transportation to and from the venue to prevent drunk driving. Another concern was response time. The response time would be no different for a residence, bar or a wedding barn. Law enforcement responds as quickly as possible to perform their duty. In addition wedding barns are beautiful structures on the outside as well and need to be well maintained in order to "get business" so in reference to "property value" I feel that is a mute point. Ask yourself this- a wedding barn that would hold 12 events a year or a private home that could potentially have loud/large parties everynight of the week (worst case scenerio of course) business's have more restrictions then private property.

I personally have used a similar venue as being requested and generally speaking people are inside of the venue and the music is ended at a relatively early hour. Traffic shouldn't be much different than what is coming/going to the Barrel Inn. On event days there may be an increase with people generally arriving during an early afternoon/evening hour and staying for a given period of time. I presume 99% of the people wouldn't notice a change. I feel it is good practice to support our business people and keep tax monies in the county as much as possible. This proposed venue would be a great addition to the Marshall area.
