4 **AUTHORIZING AN ADDENDUM TO THE AGREEMENT TO HOUSE RELOCATED DANE**
5 **COUNTY JAIL RESIDENTS AT THE IOWA COUNTY JAIL**

6 The Sheriff's Office contracts with Iowa County to provide bed space and maintenance
7 for residents committed to the Dane County Jail that are relocated and housed in the Iowa
8 County Jail; 2022 RES-351, Contract # 15024, original contract amount \$230,000.
9

10 For 2023, the cost for Dane County jail residents housed at the Iowa County Jail has
11 exceeded the contract amount. This addendum seeks authorization to increase the contract
12 amount by \$115,000, from \$230,000 to \$345,000 to cover the cost of housing Dane County jail
13 residents in the Iowa County Jail through December 31, 2023. Funding for jail resident housing
14 relocation was approved in the 2023 budget.

16 **NOW, THEREFORE, BE IT RESOLVED** that the County Executive and the Dane
17 County Clerk are hereby authorized to execute, on behalf of the County of Dane, an addendum
18 to increase the amount of Contract #15021 by \$115,000, from \$230,000 to \$345,000 to cover
19 the cost for housing Dane County Jail residents at the Iowa County Jail for the remainder of
20 2023.



DANE COUNTY CONTRACT

ADDENDUM # 15024A

Revised 01/2022

THIS ADDENDUM, made and entered into effective as of the date by which both parties hereto have executed this document, by and between the County of Dane (hereinafter referred to as "County") and County of Iowa (hereinafter, "Provider").

WITNESSETH:

WHEREAS Provider and County, by a separate document (hereinafter, the "Master Agreement"), Dane County Contract # 15024, have previously entered into a contractual relationship pursuant to which Provider furnishes bed space and maintenance for residents/inmates committed to the Dane County Jail, and

WHEREAS County and Provider wish to amend the Master Agreement in order to increase the total cost of the contract an additional \$115,000 from \$230,000 to \$345,000.

NOW, THEREFORE, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

1. The Master Agreement shall remain in full force and effect unchanged in any manner by this addendum except as changes are expressly set forth herein. This addendum shall control only to the extent of any conflict between the terms of the Master Agreement and this addendum.
2. The Master Agreement, and any amendment or addendum to it, may be executed and transmitted to any other party by legible facsimile reproduction or by scanned legible electronic PDF copy, and utilized in all respects as, an original, wet-inked manually executed document. Further, the Master Agreement and any amendment or addendum thereto, may be stored and reproduced by each party electronically, photographically, by photocopy or other similar process, and each party may at its option destroy any original document so reproduced. All parties hereto stipulate that any such legible reproduction shall be admissible in evidence as the original itself in any judicial, arbitration or administrative proceeding whether or not the original is in existence and whether or not such reproduction was made by each party in the regular course of business. This term does not apply to the service of notices under the Master Agreement, or any subsequent amendment or addendum.
3. The total cost of the contract is increased \$115,000 from \$230,000 to \$345,000.
