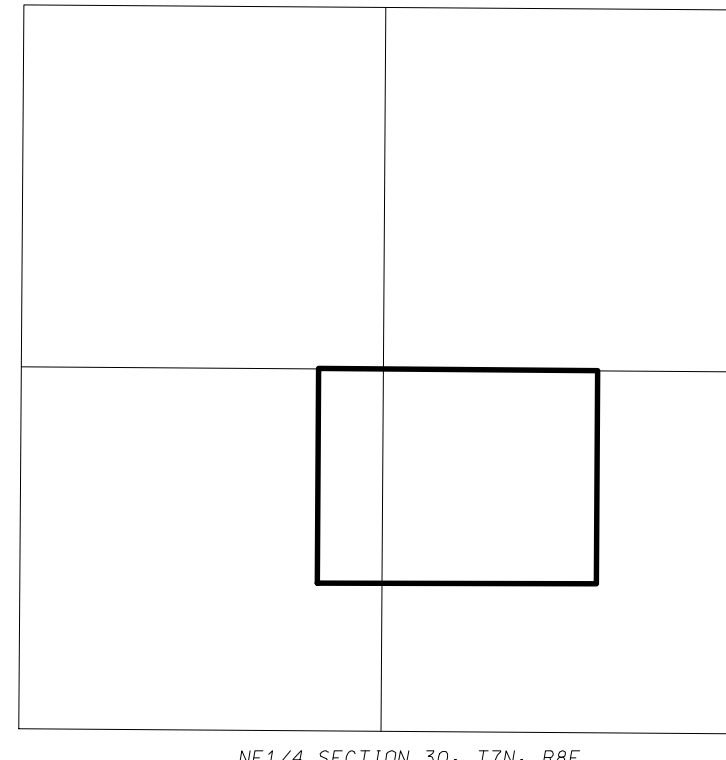


**LEGAL DESCRIPTION**
