- 1) Add new paragraph at line 270: "Mead and Hunt shall also recommend immediate solutions to bring all of our jail facilities into compliance with the Prison Rape Elimination Act (PREA) standards to ensure the safe care and custody of youthful offenders."
- 2) Add at the end of line 280: "Upon receiving these long-term recommendations from the workgroups, the county board shall consider whether to retain a consultant to develop and implement long-term proposals from the workgroups, with the goals of reducing our jail population, improving facilities, and addressing the needs of inmates."
- 3) Delete lines 296 to lines 315.

The motion was seconded by Wegleitner. Motion to amend failed 2-4 (Veldran, Clausius, Levin, Zweifel), YGP 1-0.

Zweifel moved the following amendment to Sub 1, Res 556:

- Line 297 delete "for the consolidation of functions and operations at the PSB site; as"
- Line 298 delete "detailed in the Needs Assessment and Master Plan."
- Line 308 delete "the PSB for"

The motion was seconded by Clausius. Motion to amend carried 4-2 (Levin, Veldran) YGP 1-0

Sup Dye moved the following amendment to Sub 1, Res 556:

- Change Line 315 to read "Reduction in jail population due to reduction and elimination of racial disparities."
