Katie Kluesner Gallagher, West Madison Senior Coalition Executive Director, answered Committee members' questions about the proposed meal site relocation.

D. Presentations

SOUTH MADISON COALITION OF THE ELDERLY MEAL SITE

Peg Brunner, SMCE's Office Manager, assumed duties as Nutrition Program Coordinator at the Fisher Taft Apartments and Romnes Apartments sites in June. The Fisher Taft site serves approximately 20 congregate and two home-delivered meals within the complex. The Romnes site averages 20-25 congregate diners and supplies six home-delivered meals within the complex. SMCE's third dining site, the Madison Senior Center, serves similar numbers. The Fisher Taft site manager resigned recently and a search continues for a replacement.

All diners at Fisher Taft are residents of the complex. Brunner stated the door to the site is locked for safety reasons and that publicity for the site directs interested parties to call her, at which time she provides information about the site, including how to enter. A Case Manager visits the each nutrition site once a week.

E. Reports to Committee

Cheryl Batterman, Area Agency on Aging of Dane County Manager, reported the proposed 2018 AAA Budget has been submitted to Adult Community Services Division Administrator Todd Campbell. Batterman and AAA Aging Programs Specialist Angela Velasquez are prohibited from discussing the budget until Department of Human Services Director Lynn Green presents it at a public hearing in mid-September.

Batterman reported the AAA Board approved the Committee's Home-Delivered Meal Waitlist Policy and Meal Utilization Policy at its July meeting. The Meal Utilization Policy, which called for the cessation of weekend home-delivered meals through the end of 2017 to address a funding shortfall, was scheduled to take effect on 17 July. Shortly before that date, the Department of Human Services allocated funding to continue home-delivered meals seven days a week through the end of 2017.

Batterman reported two interns will soon begin work at AAA. Kate Doyle's first day is 29 August. Hannah Nerenhausen's first day is 6 September.
