Award of contract for Inspection and Re-inspection of Bridges in Various Municipalities in Dane County

Policy Analysis Statement:

Brief Description of Proposal -

The Dane County Dept of Public Works, Highway and Transportation requires a WisDOT approved professional engineering firm to perform bridge inspections and re-inspections of off-system bridges in various municipalities within Dane County in accordance with Wisconsin Statutes 84.17 and TRANS 212, Standards for the Inspection of the Bridges in the State of Wisconsin.

Current Policy or Practice -

The Purchasing Division solicited Requests for Proposals (RFP's) for the bridge inspections and re-inspections. Two responses were received, and Corre Inc was awarded the bid.

Impact of Adopting Proposal -

Bridge inspections will be performed in accordance with Wisconsin Statutes 84.17 and TRNS 212.
