Policy Analysis Statement:

Brief Description of Proposal -

For many years, the Department of Human Services has annually contracted University Health Care, Inc. for inpatient psychiatric care at UW Hospital for indigent individuals as an alternative to Mendota Mental Health Institute (MMHI) and Winnebago Mental Health Institute (WMHI). The Dane County Board of Supervisors previously approved a 2015 professional services contract with University Health Care, Inc. However, the University has reorganized, and University Health Resources, Inc. is now the corporation responsible for UW
