Stoughton Area Senior Center Executive Director Cindy McGlynn stated representatives from 14 Focal Points convened to discuss and rank seven funding priorities for AAA's 2017 budget. A consensus was reached. The rankings were shared with and agreed to by Sugar River Senior Center, which was not represented at the meeting.

Frazier stated he is more comfortable with the priorities established during the meeting than he was with the results of an April survey of Focal Point Directors, and suggested an annual meeting be held to establish recommended budget priorities for submission to the Committee. Frazier is hopeful the process will spur Focal Point Directors to become more active in the budget-advocacy process.
