

Comprehensive Plan Document

The Town's Comprehensive Plan is a policy document that guides the future of the Town. It is primarily used to make decisions about lot splits and new development. The Town's previous plan was adopted in 2006, and for two years the Plan Commission has been working on a substantial update. A new plan was adopted by the Town Board on November 13, 2018. However, it must also be adopted by Dane County. It is expected that the new plan will be fully adopted by February 2019.

Adoption Process and Timeline

August 23rd – The Plan Commission adopted the draft plan, kicking off a process to release it for a formal 30 day public comment period.

October 2nd – The Town of Verona Board of Supervisor held a public hearing on the draft plan. Written comments were provided to the Board and people were encouraged to speak during the public hearing. The Town Board moved to postpone adoption until the Plan Commission could review the comments received and make edits.
